## Letter to New Registered Shareholder(s) – Elections as to Means of Receipt and Language of Corporate Communication(s)

If the Company does not receive the enclosed Reply Form duly completed and signed by you or does not receive a response indicating an objection from you by 24th October, 2024, unless you have otherwise previously elected to receive Corporate Communication(s) in printed form, you will be deemed to have agreed to receive the Website Version instead of printed copies of all future Corporate Communication(s).

You have the right at any time to change your elected means of receipt and choice of language of the Corporate Communication(s) by providing reasonable notice in writing (not less than 7 days) to the Company c/o the Share Registrar or email at <u>alliedgroup@computershare.com.hk</u>. If for any reason you have difficulty in receiving or gaining access to the Website Version of the Corporate Communication(s), the Company will, upon your request in writing or by email, promptly send the printed version(s) of the Corporate Communication(s) to you free of charge.
