**Letter to New Registered Shareholder(s) –

Pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“**Stock Exchange**”), Allied Group Limited (“**Company**”) is writing to seek your election regarding the means of receipt and language of corporate communication(s) of the Company (“**Corporate Communication(s)**”) to be dispatched in the future.

If for any reason you have difficulty in receiving or gaining access to the Website Version of the Corporate Communication(s), the Company will, upon your request in writing or by email, promptly send the printed version(s) of the Corporate Communication(s) to you free of charge.
