# GENERAL MANDATES TO REPURCHASE SHARES AND TO ISSUE NEW SHARES, RE-ELECTION OF DIRECTORS AND NOTICE OF ANNUAL GENERAL MEETING

#### INTRODUCTION

The purpose of this circular is to provide you with information regarding the ordinary resolutions to be proposed at the AGM to enable you to make an informed decision on whether to vote for or against those resolutions.

At the AGM, resolutions will be proposed for the Shareholders to approve, among other things:

- (i) the grant of the General Mandate to the Directors;
- (ii) the grant of the Repurchase Mandate to the Directors; and
- (iii) the proposed re-election of retiring Directors.

#### **GENERAL MANDATE**

At the AGM, an ordinary resolution will be proposed that the Directors be granted the General Mandate in order to provide flexibility and discretion to the Directors to allot, issue and deal with Shares with an aggregate value of not more than 20% of the aggregate nominal value of the share capital of the Company in issue. As at the Latest Practicable Date, the Company had 8,007,350,000 Shares in issue. Subject to the passing of an ordinary resolution approving the proposed General Mandate and on the basis that no further Shares will be issued, allotted or repurchased by the Company prior to the AGM, the exercise of the proposed General Mandate in full would result in up to a maximum of 1,601,470,000 Shares, representing 20% of the total number of Shares in issue, being issued by the Company during the period ending on the earliest of (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by laws or the Articles to be held; or (iii) the date upon which the authority given to the Directors to exercise the proposed General Mandate is revoked or varied by way of an ordinary resolution of the Shareholders in general meeting. In addition, an ordinary resolution will also be proposed by the Company to extend the proposed General Mandate by adding to it the number of such Shares repurchased under the proposed Repurchase Mandate.

#### THE REPURCHASE MANDATE

At the annual general meeting of the Company held on August 28, 2012, a general mandate was granted by the Shareholders to the Directors to exercise the powers of the Company to repurchase Shares. Such mandate will lapse at the conclusion of the AGM. An ordinary resolution will be proposed at the AGM to grant the Repurchase Mandate to the Directors. As at the Latest Practicable Date, the Company had 8,007,350,000 Shares in issue. Subject to the passing of an ordinary resolution approving the proposed Repurchase Mandate and on the basis that no further Shares will be issued, allotted or repurchased by the Company prior to the AGM, the exercise of the proposed Repurchase Mandate in full would result in up to a maximum of 800,735,000 Shares, representing 10% of the total number of Shares in issue, being repurchased by the Company. An explanatory statement as required under the Listing Rules to provide the requisite information of the proposed Repurchase Mandate is set out in Appendix I to this Circular.

#### RE-ELECTION OF DIRECTORS

The Board currently consists of ten Directors. The executive Directors are Mr. Gao Dekang, Ms. Mei Dong, Ms. Gao Miaoqin, Ms. Huang Qiaolian, Mr. Mak Yun Kuen and Mr. Rui Jinsong, and the independent non-executive Directors are Mr. Dong Binggen, Mr. Wang Yao, Dr. Ngai Wai Fung and Mr. Lian Jie.

Pursuant to Article 87 of the Articles, Mr. Gao Dekang, Ms. Huang Qiaolian, Mr. Mak Yun Kuen and Mr. Dong Binggen shall retire by rotation. Mr. Gao Dekang, Ms. Huang Qiaolian, Mr. Mak Yun Kuen and Mr. Dong Binggen, being eligible, have offered themselves for re-election at the AGM.

Details of the Directors proposed to be re-elected at the AGM are set out in Appendix II to this circular.

# EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

This appendix serves as an explanatory statement as required under the Listing Rules, to provide the requisite information to the Shareholders for consideration of the proposed Repurchase Mandate.

#### Share capital

As at the Latest Practicable Date, the issued share capital of the Company comprised 8,007,350,000 fully paid-up shares. As at the Latest Practicable Date, there were no outstanding Shares granted under the Share Option Scheme.

Subject to the passing of the proposed ordinary resolution approving the proposed Repurchase Mandate and on the basis that no further Shares are issued, allotted or repurchased by the Company prior to the AGM, the exercise of the proposed Repurchase Mandate in full would result in up to a maximum of 800,735,000 Shares, representing 10% of the total number of Shares in issue, being repurchased by the Company during the period ending at the earliest of (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by laws or the Articles to be held; or (iii) the date upon which the authority given to the Directors to exercise the proposed Repurchase Mandate is revoked or varied by way of an ordinary resolution of the Shareholders in general meeting.

#### Reasons for Shares repurchase

The Directors believe that the flexibility afforded by the proposed Repurchase Mandate would be beneficial to the Company and the Shareholders. At any time in the future when the Shares are trading at a discount to their underlying value, the ability of the Company to repurchase the Shares may be beneficial to the Shareholders who retain their investment in the Company as their percentage interest in the assets of the Company would increase in proportion to the number of Shares repurchased by the Company from time to time. This may, depending on market conditions and funding arrangements at the time, result in an increase in the net asset value and/or earnings per Share. Such repurchases will only be made when the Directors believe that such exercises will benefit the Company and the Shareholders as a whole.

#### Funding of repurchase

The Directors propose that the repurchase of Shares under the proposed Repurchase Mandate would be financed from the Company's internal resources.

Pursuant to the Repurchase Mandate, repurchases would be funded entirely from the Company's available cash flow or working capital facilities which will be funds legally available under the laws of the Cayman Islands and the Memorandum and the Articles for such purpose.

# EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

The exercise of the proposed Repurchase Mandate in full will not have a material adverse impact on the working capital or the gearing level of the Company (as compared with the position disclosed in the audited accounts of the Company for the year ended March 31, 2014 in the results announcement of the Company dated June 26, 2014). The Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse impact on the working capital or the gearing level of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

The number of the Shares to be repurchased on any occasion and the price and other terms upon which the same are purchased will be decided by the Directors at the relevant time having regard to the circumstances then pertaining.

#### **Takeovers Code**

If, as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code. Accordingly, a Shareholder, or group of Shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best knowledge and belief of the Directors, the controlling Shareholders (as defined in the Listing Rules) of the Company, namely Kong Bo Investment Limited, Kong Bo Development Limited, Kova Group Limited, Mr. Gao Dekang and Ms. Mei Dong (the "Controlling Shareholders"), together controlled the exercise of approximately 65.08% of the voting rights in the Company's general meeting. If the Directors fully exercise the proposed Repurchase Mandate, the percentage of voting rights in the Company's general meeting held by the Controlling Shareholders would increase to approximately 72.32% of the Company's issued share capital. To the best knowledge and belief of the Directors, such increase will not give rise to an obligation to make a mandatory offer under the Takeovers Code. The Directors also have no intention to repurchase Shares to such an extent which will result in the number of Shares held by the public being reduced to less than 25% as required under Rule 8.08 of the Listing Rules.

The following sets out the particulars of the retiring Directors proposed to be re-elected at the AGM.

Mr. Gao Dekang, aged 62, is the Chairman of the Board of Directors of the Company. Mr. Gao is the representative of the 10th to 12th National Congress and a National Model Worker (全國勞動模範). Mr. Gao is the founder of the Group and is responsible for the overall strategic development of the Group. He has over 30 years' of experience in the apparel industry. Mr. Gao has also assumed leadership in various associations, such as being the Vice President of China National Garment Association in 2004, the First Deputy Director of the Down Apparel and Related Products Committee of China National Garment Association in 2006, the President of Textile & Garment Chamber of Commerce, All-China Federation of Industry & Commerce in 2010 and being a Member of the Executive Committee of China Federation of Industry and Commerce, an Invited Vice President of China National Light Industry Council, the Chairman of the Board of China Federation of Industrial Economics and an Invited Vice Chairman of China National Textile and Apparel Council in 2012 respectively. In 2009, he was elected as "Outstanding Administrator of the 30th Anniversary (30周年傑出 管理者)", "National Economic Figure on the 60th Anniversary of the PRC (新中國成立60周年 全國經濟新聞人物)", "China CEO (中國CEO年度人物)", "Meritorious Entrepreneur of China Feather and Down Industry (中國羽絨行業功勳企業家)", "60 Outstanding Brand Builders in Memory of the 60th Anniversary of the PRC (建國60年60位功勳品牌人物)" and "Excellent Contributor of Chinese Socialism (優秀中國特色社會主義事業建設者)". In 2011, he was elected as "Leader of Textile and Apparel Industry in China (中國紡織服裝領軍人物)" and "Person of the Year award of the Leaders (《領袖人物》年度人物大獎)". In 2012, he was elected as "China Charity Award (中華慈善獎)". In 2013, he was elected as "China's Outstanding Quality People (中國傑出質量人)". He is a senior economist and a senior engineer. Mr. Gao received an EMBA degree (majoring in Business Administration) from Phoenix International University in New Zealand in 2002, and obtained a Master's degree in business management from Victoria University in Switzerland in 2012.

Mr. Gao had not held any directorship in any other public listed companies during the three years preceding the Latest Practicable Date. Pursuant to the existing service agreement between Mr. Gao and the Company, the appointment of Mr. Gao was for a fixed term of three years commencing from September 15, 2007 renewable automatically for successive terms of one year, unless and until terminated by either party by giving a three-month written notice. Mr. Gao is subject to retirement by rotation and re-election in accordance with the Articles. The current director's fee payable to Mr. Gao is RMB480,000 per year and may, subject to the discretion of the Directors, be reviewed. The remuneration package of Mr. Gao is determined by reference to his duty, qualification and experience and the prevailing market rate.

As at the Latest Practicable Date, Mr. Gao was interested and deemed to be interested in 5,211,554,898 Shares (within the meaning of Part XV of the SFO), representing approximately 65.08% of the issued share capital of the Company. Save that Mr. Gao is the spouse of Ms. Mei Dong (a Controlling Shareholder and Director), father of Mr. Gao Xiaodong (a Controlling Shareholder), cousin of Ms. Gao Miaoqin (a Director), Mr. Gao did not have any relationship with any Directors, senior management, substantial Shareholders or Controlling Shareholders as at the Latest Practicable Date.

Save as disclosed above, there are no other matters concerning the re-election of Mr. Gao as a Director that need to be brought to the attention of the Shareholders and there are no other matters which shall be disclosed pursuant to Rule 13.51(2) of the Listing Rules.

Ms. Huang Qiaolian, aged 49, is a Director and the Vice President of the Company and the General Manager of Shanghai Bosideng Fashion Design and Development Centre Co., Ltd. (a subsidiary of the Company) and was appointed as an executive Director in June 2007. Ms. Huang is responsible for conducting the monographic study on the fashion trend of down apparel, unveiling the fashion trend and designing high-end down apparel products. Her works have been displayed in numerous exhibitions in countries such as Korea, Canada and Russia. She received various honours such as contemporary renowned designer, one of the top ten fashion designers in China and the contributing designer in publishing the research on the garment trend in China. She has over 20 years' experience in the fashion industry. She serves various positions in different associations and organizations, such as the Council Member in China of the Fashion Art Committee of China Fashion Association (中國服裝設計師協會時裝 藝術委員會) and the special researcher for the fashion trend of China Fashion. Ms. Huang joined Bosideng Corporation in March 1997 and remained with the Group after the reorganization of the businesses of the Group prior to its listing. She graduated from the School of Fashion Design in Jiangsu (江蘇服裝設計學校) in 1987 and further studied in Donghua University majoring in High Fashion in 1994 and the Public School of High Fashion in Paris, France (法國巴黎高級時裝公學院) in 1999. She studied in East China Normal University in Shanghai majoring in Business Administration in 2004.

Ms. Huang had not held any directorship in any other public listed companies during the three years preceding the Latest Practicable Date. Pursuant to the service agreement between Ms. Huang and the Company, the appointment of Ms. Huang was for a fixed term of three years commencing from September 15, 2007, renewable automatically for successive terms of one year, unless and until terminated by either party by giving a three-month written notice. Ms. Huang is subject to retirement by rotation and re-election in accordance with the Articles. The current director's fee payable to Ms. Huang is RMB180,000 per year and may, subject to the discretion of the Directors, be reviewed. The remuneration package of Ms. Huang is determined by reference to her duty, qualification and experience and the prevailing market rate.

As at the Latest Practicable Date, (i) Ms. Huang did not have any relationship with any Directors, senior management, substantial Shareholders or Controlling Shareholders; and (ii) Ms. Huang was deemed to be interested in 2,763,697 Shares (within the meaning of Part XV of the SFO), representing approximately 0.03% of the issued share capital of the Company.

Save as disclosed above, there are no other matters concerning Ms. Huang's re-election that need to be brought to the attention of the Shareholders and the Stock Exchange and there are no other matters which shall be disclosed pursuant to Rule 13.51(2) of the Listing Rules.

Mr. Mak Yun Kuen, aged 38, is an executive Director, company secretary and the chief financial officer of the Company. Mr. Mak is responsible for the overall financial and accounting affairs, investor relations and company secretarial affairs of the Company. In addition, Mr. Mak is the director and/or company secretary of certain subsidiaries in the Group. He joined the Company in July 2008 and was appointed as an executive Director with effect from May 2013. Mr. Mak graduated from Lingnan University with a Bachelor's Degree in Business Administration (Honours), and is a member of the Hong Kong Institute of Certified Public Accountants and a fellow of the Association of Chartered Certified Accountants. Before joining the Group, Mr. Mak was the qualified accountant and company secretary of Golden Eagle Retail Group Limited (03308), a company listed on the Stock Exchange.

Mr. Mak had not held any directorship in any other listed public companies during the three years preceding the Latest Practicable Date. Mr. Mak has entered into a service agreement with the Company for an initial term of three years commencing from May 1, 2013 renewable automatically for successive terms of one year, unless and until terminated by either party by giving a three-month written notice. Mr. Mak is subject to retirement by rotation and re-election in accordance with the Articles. The current director's fee payable to Mr. Mak is RMB180,000 per year and may, subject to the discretion of the Directors, be reviewed. The remuneration package of Mr. Mak is determined by reference to his duty, qualification and experience and the prevailing market rate.

As at the Latest Practicable Date, (i) Mr. Mak did not have any relationship with any Directors, senior management, substantial Shareholders or controlling Shareholders; and (ii) Mr. Mak did not have any interest in the shares, underlying shares or debentures of the Company and/or its associated corporations (within the meaning of Part XV of the SFO).
