To be valid, this form of proxy, together with the power of attorney or other authority, if any, under which it is signed, or a notarially certified copy of that power or authority must be deposited at the Company's branch share registrars, Tricor Secretaries Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Admiralty, Hong Kong not less than 48 hours before the time appointed for the holding of this annual general meeting (i.e. not later than 10:00 a.m. on Tuesday, 3 December 2024) or any adjourned meeting.
- 6. In the case of joint holders of a share, the vote of the person, whether attending in person or by proxy, whose name stands first on the Register of Members of the Company in respect of such share shall be accepted to the exclusion of the vote(s) of the other joint holder(s).
- 7. This form of proxy must be signed by you or your attorney duly authorised in writing or, if you are a corporation, must either be executed under seal or under the hand of an officer or attorney duly authorised.
- 8. The proxy need not be a member of the Company but must attend the meeting in person to represent you.
- 9. Completion and delivery of this form of proxy shall not preclude you from attending and voting in person if you so wish and, in such event, the proxy shall be deemed to be revoked.
- 10. Any alteration to this form of proxy must be initialled by the person who signs it.
- 11. The description of the resolutions set out above is by way of summary only. The full text of the resolutions is set out in the notice of the annual general meeting.
- 12. **This form is for registered shareholders only.** If you are a non-registered shareholder, i.e. your shares in the Company are held through banks, securities brokers, custodians or other agents (each of which being hereinafter referred to as an "**Intermediary**"), this form is for your information only and you should contact your Intermediary for any doubt as to attendance and/or voting at the meeting.

The Company has absolute discretion to deal with any proxy forms including rejecting any form of proxy which is incomplete, improperly completed, illegible, or where it is difficult to ascertain from it the intention of the shareholder making the appointment or where its contents contradict another form of proxy submitted by or on behalf of the same shareholder.
- 14. This Hong Kong proxy form is to be used solely by the Company's shareholders whose shares are recorded under the Company's Hong Kong branch share registrar or the Company's Bermuda principal registrar. If your shares in the Company are recorded under the Company's Australia branch share registrar, please complete the proxy form distributed by the Company's Australia branch share registrar, Computershare Investor Services Pty Limited.
