THE ACQUISITION

The Company, through CLSIL, a wholly-owned subsidiary of the Company, acquired on-market a total of 200 PLTR Shares on 7 February 2025 at an average price of approximately US\$111.75 per share for an aggregate purchase price of approximately US\$22,350 equivalent to approximately HK\$174,330 (excluding transaction costs), which was the market price of the PLTR Shares. The purchase price was paid in cash from internal resources of the Company.

The purchase price of US\$111.75 per share represents:

- (i) a premium of approximately 0.8% to the closing price of US\$110.85 per PLTR Share as quoted on the NYSE on 7 February 2025;
- (ii) a premium of approximately 9.3% to the average of the closing prices of the PLTR Shares as quoted on the NYSE for the last five (5) consecutive trading days up to including 7 February 2025 of approximately US\$102.21 per PLTR Share; and
- (iii) a premium of approximately 22.8% to the average of the closing prices of the PLTR Shares as quoted on the NYSE for the last ten (10) consecutive trading days up to including 7 February 2025 of approximately US\$91.02 per PLTR Share.

PREVIOUS ACQUISITIONS

Reference is made to the announcement of the Company dated 18 July, 26 July, 22 August and 19 September 2024 in relation to the Previous Acquisitions.

From 9 May 2024 to 16 September 2024, the Company through its wholly-owned subsidiaries, CLP and CLSIL, have acquired a total of 19,600 PLTR Shares on the open market at an average price of approximately US\$30.08 per PLTR Share for an aggregate purchase price of approximately US\$589,657 (excluding transaction costs) equivalent to approximately HK\$4,599,000.

The total purchase price paid for the Acquisition and the Previous Acquisitions was approximately US\$612,007 (excluding transaction costs) equivalent to approximately HK\$4,773,600 for a total of 19,800 PLTR Shares at an average price of US\$30.91 per PLTR Share.

The Acquisition is in alignment with the Group's principal business on securities investments. It is believed that technological innovation is an important engine for future economic development and considering that PLTR is a fast growing American technology company with accelerating sales growth, expanding margins and rising profits, the Acquisitions represent an investment opportunity of the Group to diversify its securities investments into a different sector and which will provide satisfactory return.

As the Acquisition was made at market price, the Directors are of the view that the Acquisition is fair and reasonable, on normal commercial terms and in the interests of the Company and its Shareholders as a whole.
