## **PROPOSED CHANGE OF AUDITORS**

This announcement is made by China Netcom Technology Holdings Limited (the “**Company**”) pursuant to Rule 17.50(4) of the Rules (the “**GEM Listing Rules**”) Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited.

The board (“**Board**”) of directors (“**Directors**”) of the Company announces that HLB Hodgson Impey Cheng Limited (“**HLB**”) has resigned as the auditors of the Company and its subsidiaries (the “**Group**”) with effect from 8 November 2018 as the Company and HLB could not reach a consensus on the audit fees for the financial year ending 31 December 2018.

The Board resolved, with the recommendation from the audit committee of the Company, to propose to appoint Baker Tilly Hong Kong Limited (“**Baker Tilly**”) as the new auditors of the Group to fill the casual vacancy arising from the resignation of HLB, subject to the approval of the shareholders of the Company (the “**Shareholders**”) at the extraordinary general meeting (“**EGM**”) pursuant to the articles of association of the Company. Baker Tilly will hold office until the conclusion of the next annual general meeting of the Company.

A circular containing, among other things, details of the proposed change of auditors of the Group together with a notice of the EGM will be despatched to the Shareholders as soon as practicable.

HLB has confirmed in its resignation letter to the Company dated 8 November 2018 that there are no matters in relation to its resignation that need to be brought to the attention of the Shareholders. The Board has also confirmed that there are no other matters in relation to the proposed change of auditors that need to be brought to the attention of the Shareholders.

The Board would like to take this opportunity to express its sincere gratitude to HLB for its professional services and support in the past.
