**ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS**

## SUMMARY

### Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.46 per Offer Share (excluding brokerage fee of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.46 per Offer Share, the net proceeds from the Global Offering to be received by the Company after deducting the underwriting fees and commissions and estimated expenses payable by the Company in relation to the Global Offering, is estimated to be approximately HK\$63.3 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

### Applications Under the Hong Kong Public Offering

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been significantly over-subscribed. A total of 6,598 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service ([www.hkeipo.hk](http://www.hkeipo.hk)) for a total of 3,830,090,000 Hong Kong Offer Shares, equivalent to approximately 153.20 times of the total number of 25,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering. In accordance with the clawback mechanism as mentioned in the Prospectus, the final number of the Hong Kong Offer Shares is 125,000,000 Offer Shares, representing 50% of the total number of the Offer Shares available under the Global Offering.

### International Placing

- The Offer Shares initially offered under the International Placing have been moderately over-subscribed. The final number of the Offer Shares under the International Placing is 125,000,000 Offer Shares after reallocation to the Hong Kong Public Offering, representing 50% of the total number of the Offer Shares initially available under the Global Offering. Before the said reallocation, the initial number of the Offer Shares under the International Placing is 225,000,000 Offer Shares.

- The Directors confirm that no Offer Shares have been allocated to applicants who are core connected persons, directors or existing shareholders of the Company or their respective close associates within the meaning of the Listing Rules. There will not be any new substantial shareholder (as defined in the Listing Rules) of the Company immediately after the International Placing and the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08 of the Listing Rules. The Directors confirm that the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.

Based on the Offer Price of HK\$0.46 per Offer Share, the net proceeds from the Global Offering to be received by the Company after deducting the underwriting fees and commissions and estimated expenses payable by the Company in relation to the Global Offering, is estimated to be approximately HK\$63.3 million. The Company currently intends to apply such net proceeds as follows:

- approximately HK\$19.0 million, or approximately 30.0% will be applied to merger and acquisition activities to acquire other property management companies in various locations in Guangdong Province;
- approximately HK\$15.8 million, or approximately 25.0% will be applied to supporting part of the fund required for expanding our retail and catering network by opening new outlets in different residential communities in various locations in Guangdong Province;
- approximately HK\$12.7 million, or approximately 20.0% will be applied to expanding our Ancillary Living Services by opening new outlets for our off-campus training services and laundry services in different residential communities, with similar customer profile and traffic of Clifford Estates, in various locations in Guangdong Province;
- approximately HK\$9.5 million, or approximately 15.0% will be applied to online marketing and to develop online distribution channels of our various services by utilising various online sales platforms or websites; and
- approximately HK\$6.3 million, representing approximately 10.0% of the net proceeds from the Global Offering, will be used towards working capital and other general corporate purposes.

Of the 6,598 valid applications on **WHITE** and **YELLOW** Application Forms and by **electronic application instructions** given to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service for a total of 3,830,090,000 Hong Kong Offer Shares:

- 6,424 valid applications in respect of a total of 1,724,090,000 Hong Kong Offer Shares were for the Hong Kong Offer Shares with an aggregate subscription amount based on the maximum offer price of HK\$0.46 (excluding brokerage fee of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) of HK\$5,000,000 or less, representing approximately 137.92 times of the total number of 12,500,000 Hong Kong Offer Shares initially available for allocation in pool A; and
