For this purpose, seniority will be determined by the order in which the names stand in the register of members in respect of the joint holding.

In order to be valid, this form of proxy and any power of authority (if any) under which it is signed or a certified copy of that power of authority must be deposited with the Company's Hong Kong branch share registrar and transfer office, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 48 hours before the time appointed for the holding of the Meeting or adiourned meeting.
