ENN Energy Gathers China's City Gas Industry to Control Methane Emission

(Hong Kong, 15 October 2021) the sub-conference entitled "Methane Emission Reduction Contributes to Carbon Neutrality of City Gas" under "The 11th China Gas Operation and Safety Seminar and "China Civil Engineering Society Gas Branch 2021 Academic Annual Conference"" was held in Zhengzhou, Henan. The event was jointly organized by **ENN Energy Holdings Limited (Stock code: 2688.HK; "ENN Energy" or "the Group")**, Beijing Gas Group Co Ltd and Environmental Defense Fund Beijing Office. **Mr. Liu Jianfeng, CFO of ENN Energy**, delivered the keynote speech of "Green Action 2030 -- ENN Energy's Zero-carbon Journey", and hosted the signing ceremony of "Methane Emission Control Initiative of China's City Gas Enterprises". Experts from UNEP, China Climate Change Center of Ministry of Ecology and Environment, China Civil Engineering Society, CNOOC, Beijing Gas and Chongqing University shared and discussed the development and practical application of methane emission reduction technology.



Mr. Liu Jianfeng introduced ENN Energy's zero-carbon roadmap, especially the actions to 2030 for its own emission reduction and low-carbon and clean development of customers and society. ENN Energy attaches great importance to managing methane gas emissions, reduction of which is vital to meeting the company's net zero emission target by 2050. In March 2021, ENN Energy adopted the Methane Emission Reduction Guidelines (MGP) to reduce its own emission and started adhering to MGP's 5 principles and best practices. In May, the Company became a founding member of the Methane Emission Control Alliance of China's Oil and Gas Enterprises, committing to work together with its partners to achieve the goal of reducing the average methane emission intensity in the natural gas production process to below 0.25% by 2025, an advanced level, and striving to reach global first-class standards by 2035.

ENN Energy and Beijing Gas jointly launched the "Methane Emission Control Initiative of China's City Gas Enterprises". Ten city gas enterprises then became signatories of this process.

中国城市燃气企业甲烷控排倡议

天然气是实现我国“双碳”目标和“美丽中国”的重要力量，被公认为通向未来“零”碳能源系统的过渡桥梁，将在全球能源转型中发挥重要作用。天然气的主要成分是甲烷，是仅次于二氧化碳的第二大温室气体，天然气全产业链中的甲烷排放，会削弱天然气利用带来的气候效益，影响天然气在能源转型过程中的优势地位和作用。我国碳中和目标已明确了包含甲烷在内的全经济领域的全部温室气体。对于燃气企业，甲烷则是其第一温室气体排放源。为此，城市燃气企业作为天然气全产业链中的主要力量，应与上游企业携手共进，肩负起应对气候变化过程中甲烷控排的责任，努力为实现我国“双碳”目标做出应有贡献。

我们承诺：

1. 坚定不移走绿色低碳可持续发展之路，将甲烷控排纳入各企业实现碳达峰目标和碳中和愿景的发展规划；
2. 支持政府的甲烷控排政策制定及实施，推动甲烷控排技术研发及示范应用，稳步实现甲烷控排工作国际化接轨；
3. 积极加强燃气泄漏检测与修复，完善燃气管道完整性管理，推动甲烷排放监测、报告与核查(MRV)技术体系建设；
4. 持续总结并推广行业甲烷减排最佳实践，提高透明度接受社会和公众的监督。

我们愿携手努力，积极推进行业甲烷控排行动，彰显中国燃气企业的责任担当。

In the keynote speech at the signing ceremony of the initiative, Mr. Liu Jianfeng pointed out that China's city gas industry needed to establish methane management standards and norms suitable for the domestic city gas industry and promote the development and application of monitoring and emission reduction technologies. It is the mission and responsibility of the entire industry to move towards carbon neutrality, he said. This process can only be accelerated by pooling industry forces and setting common targets and action-plans, and ultimately achieving the goal of surpassing international peers. Moreover, leading the global effort to control methane emissions and fostering climate governance are also vital, he said.

We strive to contribute to China's strength in global climate governance with forceful actions.
