1. Property Sales in Apr 2011

In April 2011, the Group recorded property sales of RMB 1.14 billion, representing an increase of 120% year-on-year. The total property sold area was 119,300 sq.m., representing an increase 160% as compared to the same period of last year. From January to April, the total property sales and property sold area amounted to RMB 4.07 billion and 430,500sq.m., representing an increase of 137% and 161 % respectively as compared to the same period of last year.

In April, Northeast China recorded the fastest growth in terms of sales amount and sold area by 2.53 times and 1.87 times year-on-year respectively. Shanghai Region also recorded fast increase in terms of sales amount and sold area by 1.63 times and 7.12 times as compared to the same period of last year.
