

Glorious Property Holdings Limited 恒盛地產控股有限公司



1. Property Sales in May 2011

In May 2011, the Group recorded property sales of RMB 1.02 billion, representing an increase of 361 % year-on-year. The total property sold area was 84,600 sq.m., representing an increase of 303 % as compared to the same period of last year. From January to May, the total property sales and property sold area amounted to RMB 5.09 billion and 515,000sq.m., representing an increase of 162 % and 177 % respectively as compared to the same period of last year.

In May, Yangtze River Delta recorded the fastest growth in terms of sales amount and sold area by 8.24 times and 5.9 times year-on-year respectively. Shanghai Region also recorded fast increase in terms of sales amount and sold area by 3.06 times and 2.83 times as compared to the same period of last year.
