

Glorious Property Holdings Limited 恒盛地產控股有限公司



1. Property Sales in July 2011

In July 2011, the Group recorded property sales of RMB 914 million, representing an increase of 35% year-on-year. The total property sold area was 124,800sq.m., representing an increase of 50% as compared to the same period of last year. From January to July, the total property sales and property sold area amounted to RMB 8.02 billion and 895,300sq.m., representing an increase of 128% and 145% respectively as compared to the same period of last year.

In July, Yangtze River Delta recorded the fastest growth in terms of sales amount and sold area by 7.78 times and 5.41 times year-on-year respectively. From January to July, Yangtze River Delta, Northeast China Region and Shanghai Region recorded high growth in terms of sales amount by 2.95 times, 1.71 times and 1.39 times year-on-year respectively.
