- The Company has issued convertible bonds in an aggregate principal amount of HK\$100,969,093.34 with conversion price of HK\$2.6 per share on 6 May 2024. Details were set out in the announcements of the Company dated 6 March 2024, 10 April 2024, 26 April 2024, 30 April 2024, 2 May 2024 and 6 May 2024 and the circular of the Company dated 10 April 2024.
- On 15 September 2025, the Company received a conversion notice from convertible bonds holder in respect of the partial exercise of the conversion rights to convert a principal amount of HK \$22,000,000 of the outstanding convertible bond at the conversion price of HK\$2.6 each (the "Conversion"). The Company has allotted and issued 8,461,538 conversion shares to the convertible bonds holder pursuant to the Conversion on 16 September 2025.
