Reference was made to the Company's announcement dated 7 March 2019 in relation to the adjustments to conversion price and number of conversion shares of convertible bonds. Unless the context requires otherwise, capitalised terms used herein shall bear the same meanings as defined.

The Conversion Price of the US\$45,000,000 Convertible Bonds had been adjusted as a result of the Placing and the Grant of Share Options. As a result of the Adjustments, the adjusted Conversion Price is HK\$0.26 and the number of Shares which may fall to be issued upon exercise in full of the conversion rights attaching to the Convertible Bonds shall be 1,350,000,000 Shares.
