1) Pursuant to the ordinary resolution passed at the special general meeting of the Company held on 5 August 2020, the Company implemented the share consolidation with effect from 7 August 2020, on the basis that every twenty (20) issued and unissued ordinary shares of the Company of HK\$0.01 each were consolidated into one (1) ordinary share of HK\$0.2 each, ranked pari passu in all respects with each other. Upon completion of the share consolidation, the Company's authorized share capital consists of HK\$2,000,000,000 divided into 10,000,000,000 ordinary shares of HK\$0.2 each, there are 526,260,404 shares in issue which are fully paid or credited as fully paid. Details of which can be referred to the relevant announcements of the Company.
