1) According to the announcement of the company published on 4 September 2020, as approved by the board of directors of the company and consented by each of the relevant grantees respectively, the company and the relevant grantees agree that an aggregate of 42,168,370 options granted to them were cancelled with effect from 4 September 2020 in accordance with the terms of the share option scheme. After the cancellation of the options, there are 1,000,000 options with exercise price of HK\$7.00 per share remain outstanding and not exercised. Details of which can be referred to the relevant announcements of the company.
