UNAUDITED OPERATING STATISTICS FOR JUNE 2017

The board of directors (the “**Board**”) of Guorui Properties Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that, in June 2017, the Group achieved (i) contracted sales of approximately RMB1,372 million, (ii) contracted sales in terms of gross floor area (“**GFA**”) amounted to approximately 86,600 sq.m. and (iii) contracted average selling price (“**ASP**”) amounted to approximately RMB16,000 per sq.m..

For the six months ended 30 June 2017, the Group achieved total contracted sales of approximately RMB5,172 million, contracted sales in terms of GFA amounted to approximately 344,100 sq.m. and contracted ASP of approximately RMB15,000 per sq.m..
