## **UNAUDITED OPERATING STATISTICS FOR MAY 2018**

The board of directors (the “**Board**”) of Guorui Properties Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that:

### **Contracted Sales**

In May 2018, the Group achieved (i) contracted sales of approximately RMB1,499 million, (ii) contracted sales in terms of gross floor area (“**GFA**”) amounted to approximately 114,038 sq.m. and (iii) contracted average selling price (“**ASP**”) amounted to approximately RMB13,200 per sq.m..

For the five months ended May 31, 2018, the Group achieved contracted sales totaling to approximately RMB4,739 million, contracted sales in terms of GFA totaling to approximately 361,538 sq.m. and contracted ASP of approximately RMB13,109 per sq.m..

### **Leasing of Investment Properties**

In May 2018, the Group achieved (i) contracted lease of investment properties of approximately RMB147 million, and (ii) contracted leased area of approximately 16,374 sq.m.. The lease term of such investment properties varies from one year to seven years.

For the five months ended May 31, 2018, the Group achieved contracted lease of investment properties of approximately RMB857 million and contracted leased area of approximately 67,897 sq.m..

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
