**The extraordinary general meeting of the Company has been held on 27 March 2020 to approve share consolidation which became effective on 31 March 2020.**

**As a result of the share consolidation:-**

**(1) the authorised share capital of the Company shall become HK\$130,000,000 divided into 1,300,000,000 consolidated shares of par value of HK\$0.10 each, of which 345,600,000 consolidated shares will be in issue.**

**(2) the number of consolidated shares to be allotted and issued under the share option scheme and the exercise price of share options adjusted to 3,607,000 shares and 34,560,000 shares which has exercise price of HK\$7.26 per share and HK\$0.41 per share respectively.**
