POLL RESULTS OF THE 2022 ANNUAL GENERAL MEETING

The board of directors (the “**Board**”) of NagaCorp Ltd. (the “**Company**”) is pleased to announce that all the resolutions proposed at the annual general meeting of the Company held on 22 April 2022 (the “**2022 AGM**”) as set out in the notice of the 2022 AGM dated 21 March 2022 (the “**Notice**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll.

As at the date of the 2022 AGM, there were a total of 4,341,008,041 issued shares of the Company (the “**Shares**”) entitling the holders to attend and vote for or against all the proposed resolutions at the 2022 AGM. There were no Shares entitling the holders to attend and abstain from voting in favour at the 2022 AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

No Shareholders were required to abstain from voting on the proposed resolutions at the 2022 AGM under the Listing Rules. No Shareholders have stated their intention in the Company’s circular dated 21 March 2022 to vote against or abstain from voting on any of the proposed resolutions at the 2022 AGM.

The branch share registrar of the Company in Hong Kong, Computershare Hong Kong Investor Services Limited, acted as the scrutineer for the vote-taking at the 2022 AGM.

The Company’s executive directors, Mr. Philip Lee Wai Tuck and Mr. Chen Yiy Fon; non-executive director, Mr. Timothy Patrick McNally; and independent non-executive directors, Mr. Lim Mun Kee, Mr. Michael Lai Kai Jin and Mr. Leong Choong Wah attended the 2022 AGM.
