VERY SUBSTANTIAL DISPOSAL EXTENSION OF LONG STOP DATE

Reference is made to the announcement of National Investments Fund Limited (the “**Company**”) dated 20 November 2018 (the “**Announcement**”) in relation to the Disposal. Unless otherwise defined herein, capitalised terms used herein shall have the same meanings as defined in the Announcement.

As disclosed in the Announcement, the Completion is conditional upon the fulfilment of the conditions precedent of the SPA on or before the Long Stop Date.

As more time is required for the fulfilment of the conditions precedent under the SPA and to complete the Disposal, on 18 February 2019 (after trading hours), the Vendor, the Purchaser and the Purchaser Guarantor have entered into a supplemental agreement to extend the Long Stop Date from 19 February 2019 to 31 May 2019. Save and except to the change on the Long Stop Date, all other terms and conditions of the SPA remain unchanged.
