#### Remarks:

Pursuant to an ordinary resolution by the shareholders of the Company at an extraordinary general meeting held on 15 August 2025, the Company (i) implemented share consolidation on the basis that every five (5) issued and unissued shares of par value of HK\$0.001 each be consolidated into one (1) consolidated share of HK\$0.005 each (the "Share Consolidation") and (ii) immediately upon the Share Consolidation becoming effective, increased its authorised share capital.

After the Share Consolidation, the Company's authorised share capital has been increased from HK\$1,000,000 divided into 1,000,000,000 shares with par value of HK\$0.001 each to HK\$1,000,000 divided into 200,000,000 consolidated shares with par value of HK\$0.005 each, and after the increase in authorised share capital, from HK\$1,000,000 divided into 200,000,000 consolidated shares with par value of HK\$0.005 each to HK\$5,000,000 divided into 1,000,000,000 consolidated shares by the creation of an additional 800,000,000 new consolidated shares.
