- To be valid this form of proxy together with any power of attorney or other authority (if any) under which it is signed or a notarially certified copy of such power of authority must be deposited at the registered office of the Company, Unit 1801, 18/F., Lu Plaza, 2 Wing Yip Street, Kwun Tong, Kowloon, Hong Kong, not less than 48 hours before the time of the meeting or any adjournment thereof.
- Any alterations made in this form must be initialled by the person who signs it.
- Completion and delivery of this form of proxy will not preclude you from attending and voting at the meeting if you so wish.
- "Business Day" means any day (excluding Saturday) on which no black rainstorm warning or a tropical cyclone warning signal number 8 or above is hoisted or remains hoisted at 10:00 a.m. on that day and on which banks in Hong Kong are generally open for business. If a black rainstorm warning or a tropical cyclone warning signal number 8 or above is hoisted at 10:00 a.m. or any time after 10:00 a.m. on 18 August 2017, the annual general meeting of the Company will not be held on that day but will be held at the same time and place on the first Business Day after 18 August 2017 instead.
