PROPOSALS FOR RE-ELECTION OF DIRECTORS AND GENERAL MANDATES TO ISSUE SHARES AND REPURCHASE SHARES AND NOTICE OF ANNUAL GENERAL MEETING

1. INTRODUCTION

The purpose of this circular is to provide you with notice of the AGM, and information on matters to be dealt with at the AGM, inter alia:

- (a) re-election of retiring Directors; and
- (b) grant of the Issue Mandate and Repurchase Mandate to Directors, and the extension of the Issue Mandate to Directors by the addition of the number of Shares repurchased pursuant to the Repurchase Mandate.

2. RE-ELECTION OF RETIRING DIRECTORS

Pursuant to article 84 of the Articles of Association, at each annual general meeting of the Company, one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. A retiring Director shall be eligible for re-election. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of Directors to retire by rotation) any Director who wishes to retire and not to offer himself/herself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment and so that as between persons who became or were last re-elected Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. Any Directors appointed by the Board pursuant to article 83(3) of the Articles of Association (to fill a causal vacancy or as an addition to the existing Board) shall not be taken into account in determining which particular Directors or the number of Directors who are to retire by rotation.

In accordance with article 84 of the Articles of Association, Mr. Yiu Hon Ming, Ms. Yiu Ho Ting and Professor Wong Lung Tak Patrick ("Professor Wong") will retire by rotation and, being eligible, have offered themselves for re-election at the AGM. Mr. Carson Wen ("Mr. Wen") has decided not to offer himself for re-election at the AGM to facilitate the Company's compliance with the revised Listing Rules on long-serving independent non-executive directors and to support the Board's commitment to good governance and orderly refreshment. Accordingly, Mr. Wen will retire as an Independent Non-executive Director at the AGM. Upon Mr. Wen's retirement at the AGM, he will cease to be a member of the Audit Committee, Remuneration Committee and Nomination Committee after the conclusion of the AGM.

Mr. Wen has confirmed that he has no disagreement with the Board and there are no matters relating to his retirement that need to be brought to the attention of the Shareholders. Mr. Wen has demonstrated dedication, diligence and conscientiousness since he joined the Board in 2011. The Board would like to express its sincere gratitude to Mr. Wen for his valuable, professional and independent opinions to the Board and for his contribution to the sustainable development of the Company.

As at the Latest Practicable Date, the length of tenure of each of the Independent Non-executive Directors is as follows:

The Nomination Committee has reviewed the structure, size, composition and diversity of the Board by taking into account the nomination policy of the Company and the objective criteria (including without limitation, gender, age, cultural background, reputation for integrity, educational background, professional experience, skills, knowledge and length of service) set out in it, and made recommendations to the Board that the re-election of the retiring Directors be proposed for Shareholders' approval at the AGM. Professor Wong, who is a member and was present at the meeting of the Nomination Committee, abstained from voting at the meeting of the Nomination Committee when his independence and nomination was being considered.

The Board is of the view that Professor Wong has made positive contributions to the Company's strategy, policies and performance with his independent advice, comments, judgment from the perspective of his strong background in accountancy and auditing coupled with his general understanding of business of the Group during his tenure as an Independent Non-Executive Director. During the tenure of his office, Professor Wong had performed his duties as Independent Non-Executive Director to the satisfaction of the Board. The Board also considers that he will continue to contribute to the diversity of the Board, in particular, with his expertise in taxation, auditing, corporate governance, risk management and financial management.

According to Code Provision B.2.3 of the Corporate Governance Code, any further appointment of independent non-executive director serving more than nine years should be subject to a separate resolution to be approved by shareholders. Professor Wong has been an Independent Non-Executive Director for more than nine years. Notwithstanding that Professor Wong has served as an Independent Non-Executive Director for more than nine years, Professor Wong does not have any management role in the Group and he has demonstrated his willingness to exercise independent judgment and has been giving objective views to the Company. There is no evidence that length of tenure is having an adverse impact on his independence. The Board is satisfied that, as well proven by the valuable independent judgment and advice given by Professor Wong over the years, Professor Wong has the required character, integrity, independence and experience to fulfill the role of an Independent Non-Executive Director. The Board is not aware of any circumstances that might influence Professor Wong in exercising his independent judgment.

Besides, Professor Wong has provided an annual confirmation of independence based on the independence criteria as set out in Rule 3.13 of the Listing Rules to the Company. The Board has reviewed the independence confirmation and is of the view that Professor Wong remains independent and should be re-elected for a further term at the AGM.

Particulars of the retiring Directors are set out in Appendix I to this circular.

3. ISSUE MANDATE AND REPURCHASE MANDATE

Pursuant to the ordinary resolutions passed at the Company's annual general meeting held on 27 May 2024, Directors were granted (i) a general and unconditional mandate to exercise their powers to allot, issue and deal with an aggregate number of Shares of up to a maximum of 10% of the number of issued Shares as at 27 May 2024; (ii) a general and unconditional mandate to repurchase an aggregate number of Shares of up to a maximum of 10% of the number of issued Shares as at 27 May 2024; and (iii) the power to extend the general mandate mentioned in (i) above by an amount representing the aggregate number of Shares repurchased by the Company pursuant to the mandate to repurchase Shares mentioned in (ii) above.

These general mandates will expire at the conclusion of the AGM. In order to provide continuous flexibility to the Directors, resolutions will be proposed at the AGM to seek the approval of Shareholders to renew these mandates.

(a) Issue Mandate

At the AGM, an ordinary resolution (Ordinary Resolution No. 4 set out in the notice of AGM) will be proposed to grant a new general and unconditional mandate to the Directors to exercise the power of the Company to allot, issue and deal with, at any time during the Relevant Period (as defined in Ordinary Resolution No. 4(d) in the notice of AGM), Shares (including any sale or transfer of Treasury Shares held in treasury, if any) up to a maximum of 10% of total number of issued Shares (excluding Treasury Shares, if any) on the date of passing of Ordinary Resolution No. 4.

As at the Latest Practicable Date, the total number of Shares in issue was 600,000,000 Shares, and there were no Treasury Shares. Subject to the passing of the proposed resolution for approving the Issue Mandate and on the basis that no further Shares are issued or repurchased by the Company prior to the date of the AGM, the Company would be allowed to issue up to a limit of 60,000,000 Shares under the Issue Mandate.

(b) Repurchase Mandate

Mr. Yiu has entered into an appointment letter with the Company for a term of three years and a service contract with two subsidiaries of the Company respectively. He is subject to the relevant provisions for retirement and re-election as Director in accordance with article 84 of the Articles of Association. Pursuant to the appointment letter and service contracts, Mr. Yiu is entitled to receive a director's fee of HKD180,000 per annum, a basic salary of HKD420,000 per annum, a discretionary bonus at the discretion of the Board and other non-cash benefits, which was recommended by the Remuneration Committee and determined by the Board by reference to his duties and responsibilities within the Group, the prevailing market conditions and the performance of the Group. Mr. Yiu received a total emolument of HKD716,000 (including a discretionary bonus of HKD120,000) from the Group for being an Executive Director and other positions in the Group for the year ended 31 December 2024.

As at the Latest Practicable Date, Mr. Yiu and his wife, Ms. Law Wai Ping, are legally and beneficially interested in 60% and 40% of the entire issued share capital of Ming Fung Holdings (Hong Kong) Limited, respectively, which in turn is directly interested in approximately 95.45% of the entire issued share capital of Ming Fung Investment Limited, which in turn is directly interested in 396,000,000 Shares, representing 66% of the entire issued share capital of the Company. Ms. Law is also directly and beneficially interested in 2,040,000 Shares, representing approximately 0.34% of the entire issued share capital of the Company. Ms. Yiu received a total emolument of HKD476,000 (including a discretionary bonus of HKD7,000) from the Group for being an Executive Director and other positions in the Group for the year ended 31 December 2024.

As at the Latest Practicable Date, Ms. Yiu is interested in 6,909,600 Shares within the meaning of Part XV of the SFO, representing 1.15% of the entire issued share capital of the Company in which Ms. Yiu is directly and beneficially interested in 5,688,000 Shares, while her husband, Mr. Cheung Justin Chi Yen ("Mr. Cheung"), is directly interested in 1,221,600 Shares. By virtue of the SFO, Ms. Yiu is deemed to be interested in the same block of Shares in which Mr. Cheung is interested. Ms. Yiu is the daughter of Mr. Yiu Hon Ming, the Chairman of the Board and an Executive Director of the Company, and Ms. Law Wai Ping, an Executive Director of the Company, and sister of Mr. Yiu Tat Sing, the Deputy Chairman of the Board and an Executive Director of the Company. PROFESSOR WONG LUNG TAK PATRICK

Professor Wong Lung Tak Patrick ("Professor Wong"), BBS, JP, aged 77, was appointed as an Independent Non-Executive Director of the Company on 24 June 2011. Professor Wong is a Certified Public Accountant (Practising) in Hong Kong, a Chartered Secretary and a Certified Tax Advisor (Hong Kong) and the Managing Practising Director of Patrick Wong CPA Limited. As at the Latest Practicable Date, Professor Wong is not interested in any Shares within the meaning of Part XV of the SFO, nor does he have any relationship with any Directors, senior management, or substantial or controlling Shareholders (as defined in the Listing Rules) of the Company. Save as disclosed above, there is no other information relating to Professor Wong that is required to be disclosed pursuant to Rule 13.51(2) of the Listing Rules and there is no other matter that needs to be brought to the attention of the Shareholders.

As at the Latest Practicable Date, 600,000,000 Shares were in issue and the Company did not have any Treasury Shares.

Exercise in full of the Repurchase Mandate, on the basis of 600,000,000 Shares in issue as at the Latest Practicable Date, would result in a maximum of 60,000,000 Shares (which are fully paid and represent 10% of the Shares in issue (excluding Treasury Shares, if any)) being repurchased by the Company during the period prior to the earliest of:

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws of the Cayman Islands to be held; or
- (iii) the revocation, variation or renewal of the Repurchase Mandate by an ordinary resolution of the Shareholders in general meeting of the Company.

The total number of Shares which the Company is authorised to repurchase its Shares representing a maximum of 10% of the total number of issued Shares (excluding Treasury Shares, if any) at the date of the resolution granting the Repurchase Mandate. A company may not issue or announce an issue of new shares for a period of 30 days immediately following a repurchase of securities (other than an issue of securities pursuant to an exercise of warrants, share options or similar instruments requiring the company to issue securities which were outstanding prior to such repurchase) without the prior approval of the Stock Exchange. The Listing Rules also prohibit a company from making repurchases of its own securities on the Stock Exchange if the repurchase would result in the number of the company's listed securities which are in the hands of the public falling below the relevant prescribed minimum percentage as required by the Stock Exchange, which is currently 25% in the case of the Company.

The Listing Rules further prohibit a company from purchasing its own shares on the Stock Exchange if the purchase price is higher by 5% or more than the average closing market price for the five preceding trading days on which its shares are traded on the Stock Exchange or for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange prevailing from time to time.

The Company shall procure that any broker appointed by it to effect the purchase of its securities to disclose to the Stock Exchange such information with respect to purchases made on behalf of the Company as the Stock Exchange may request.

(2) REASONS FOR THE REPURCHASE

Although the Directors have no present intention to repurchase any Shares, the Directors believe that it is in the best interests of the Company and the Shareholders for the Directors to seek a general authority from the Shareholders to enable the Company to repurchase Shares in the market. Repurchases of Shares will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders as a whole. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share.

(3) FUNDING OF REPURCHASE

At repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the Memorandum of Association, the Articles of Association and the applicable laws and regulations of the Cayman Islands. Pursuant to the Repurchase Mandate, repurchases will be made out of funds of the Company legally permitted to be utilised in this connection, including profits of the Company or out of a fresh issue of Shares made for the purpose of the repurchase or, subject to the Companies Law of the Cayman Islands, out of capital of the Company and, in the case of any premium payable on the repurchase, out of the profits of the Company or from sums standing to the credit of the share premium account of the Company or, subject to the Companies Law of the Cayman Islands, out of capital of the Company.

(4) IMPACT ON THE COMPANY

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in its most recent published audited accounts for the year ended 31 December 2024) in the event that the Repurchase Mandate is exercised in full. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or on its gearing position which in the opinion of the Directors are from time to time appropriate for the Company.

(5) DISCLOSURE OF INTEREST

None of the Directors to the best of their knowledge having made all reasonable enquiries, nor any of their respective close associates (as defined in the Listing Rules), have any present intention, if the Repurchase Mandate is approved by the Shareholders, to sell any Shares to the Company or its subsidiaries.

(6) DIRECTORS' UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Repurchase Mandate in accordance with the Listing Rules, the Memorandum of Association, the Articles of Association and the applicable laws of the Cayman Islands. Neither the Explanatory Statement nor the Repurchase Mandate has any unusual features.

(7) EFFECT OF TAKEOVERS CODE

If the proportionate interest of a Shareholder in the voting rights of the Company increases on exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, such increase will be treated as an acquisition of voting rights for the purpose of the Takeovers Code. Accordingly, a Shareholder, or group of Shareholders acting in concert (within the meaning of the Takeovers Code), depending on the level of increase in the Shareholders' interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, the immediate controlling Shareholder (as defined in the Listing Rules) of the Company, Ming Fung Investment Limited, was recorded in the registers required to be kept by the Company under section 336 of the SFO as interested in 396,000,000 Shares, representing 66% of the issued share capital of the Company. In the event that the Repurchase Mandate is exercised in full and assuming that there is no change in the number of Shares held by Ming Fung Investment Limited and there is no other change to the issued share capital of the Company, the shareholding of Ming Fung Investment Limited in the Company will be increased to approximately 73.33% of the reduced issued share capital of the Company immediately after the exercise in full of the Repurchase Mandate.

Accordingly, the Directors are not aware of the consequences which would give rise under the Takeovers Code as a result of exercising the Repurchase Mandate. In addition, in exercising the Repurchase Mandate (whether in full or otherwise), the Directors will ensure that the Company shall comply with the requirements of the Listing Rules, including the minimum percentage of Shares being held in public hands.

(8) SHARE REPURCHASE MADE BY THE COMPANY

No repurchase of Shares has been made by the Company (whether on the Stock Exchange or otherwise) during the six months immediately preceding the Latest Practicable Date.

(9) STATUS OF REPURCHASED SHARES

If the Company purchases any Shares pursuant to the Repurchase Mandate, the Company may (i) cancel the Shares repurchased; and/or (ii) hold such Shares in treasury, subject to market conditions and the capital management needs of the Company at the relevant time such repurchase of Shares are made. If the Company holds any Shares in treasury, any sale or transfer of Treasury Shares held in treasury will be subject to the Issue Mandate and made in accordance with the Listing Rules and applicable laws and regulations of the Cayman Islands.

For those Treasury Shares (if any) not directly held by the Company but are deposited with CCASS pending resale on the Stock Exchange, the Company will adopt measures to ensure that it would not exercise any Shareholders' rights or receive any entitlements in respect of such Treasury Shares. Such measures will include (i) procuring the relevant broker not to give instructions to HKSCC to vote at general meetings of the Company for such Treasury Shares; and (ii) in case of dividends or distributions, the Company shall give instructions to the Company's branch share registrar to exclude such Treasury Shares in determining HKSCC's entitlements to the dividends or distributions and notify (or procure the relevant broker to notify) HKSCC the number of Treasury Shares held with CCASS, or alternatively, withdraw the Treasury Shares from CCASS and either register them in the Company's own name or cancel them, in each case before the record date for the dividend or distributions.

(10) CONNECTED PARTIES

The Listing Rules prohibit a company from knowingly repurchasing securities on the Stock Exchange from a "core connected person", that is, a director, chief executive or substantial shareholder of the company or any of its subsidiaries or their respective close associates (as defined in the Listing Rules), and a core connected person shall not knowingly sell his securities to the company on the Stock Exchange. No core connected person (as defined in the Listing Rules) of the Company has notified the Company that he has a present intention to sell any Shares to the Company, or has undertaken not to do so, in the event that the Repurchase Mandate is approved by Shareholders.
