On 29 August 2018 (after trading hours), the Company has entered into a subscription agreement with Cathy Capital Holdings Limited (the "Subscriber"), pursuant to which the Subscriber has agreed to subscribe for, and the Company has agreed to issue, the convertible notes in the principal amount of HK\$2,000,000. Based on the initial conversion price of HK\$0.048, a maximum number of 41,666,666 conversion shares may fall to be allotted and issued upon exercise by the noteholders of the conversion rights attached to the convertible notes in full. Completion of the subscription agreement is subject to the fulfilment of the conditions precedent as set out in the announcement dated 29 August 2018 and the supplemental announcement dated 30 August 2018 (the "Announcements").
