Event details: In accordance with a resolution passed at the special general meeting held on 31 July 2012, “融達控股有限公司” was adopted as the Chinese name of the Company for identification purposes, while the English name of the Company “Z-Obee Holdings Limited” remained unchanged to facilitate the trading of its shares in The Stock Exchange of Hong Kong Limited. In line with the changes in listing status in Singapore from a primary listing to a secondary listing whilst retaining the primary listing in Hong Kong in June 2013, the Taiwan Depository Receipts of the Company listed in the centralized securities trading market of the Taiwan Stock Exchange Corporation intends to change the Chinese stock short name to “融達” with effect from 15 November 2013, while the English stock short name “Z-Obee” and the stock code “910948” remains unchanged. 6. Responsive measures: The introduction of Chinese name and the change of stock short name of the Company will have no impact on any of the rights of Taiwan Depository Receipts holder. The existing Taiwan Depository Receipts and original shares are still valid documents of certification of shares and can be validly traded, cleared, settled and registered. The Company will not make any arrangement concerning the free conversion of existing share certificates. The new share certificates will be issued under the name of the Company and its Chinese name. 7.
