FURTHER DELAY IN DESPATCH OF THE CIRCULAR

Reference is made to the announcements of the Company dated 22 April 2016 and 16 May 2016 (the “**Announcements**”) in relation to, among others, the Proposed Restructuring. Unless otherwise defined, capitalized terms used herein shall have the same meanings as those defined in the Announcements.

As stated in the Announcements, the Company would despatch the Circular in relation to the Proposed Restructuring on or before 5 October 2016. On 7 September 2016, the Company duly submitted the Resumption Proposal to the Stock Exchange. As the Share Subscription is subject to, among others, the in-principal approval of the Stock Exchange for the Resumption, no formal subscription agreement in relation to the Share Subscription has been entered into as at the date of this announcement. Nevertheless, there is no certainty that the Stock Exchange will approve the Resumption Proposal and therefore the Proposed Restructuring may or may not proceed. As such, the Company has applied to the Executive for its consent to extend the date of despatch of the Circular to no later than 31 March 2017 and the Executive has indicated that it is minded to grant such consent.

At the request of the Company, trading in the Shares on the Stock Exchange was suspended with effect from 2:37 p.m. on 27 June 2014 and will remain suspended until further notice.
