As approved by the special general meeting of the Company held on 16 October 2017, the capital reorganisation has come into effect on 17 October 2017. Immediately after the capital reorganisation becoming effective, (i) every twenty (20) existing shares of US\$0.008 each has been consolidated into one (1) consolidated share of US\$0.16 each, with the issued and paid-up share capital changed from US\$6,101,501.296 divided into 762,687,662 shares to US\$6,101,501.280 divided into 38,134,383 consolidated shares; and (ii) the existing authorised share capital of the company has been increased from US\$10,000,000.00 to US\$100,000,000.00, divided into 625,000,000 consolidated shares of US\$0.16 each by the creation of 562,500,000 new consolidated shares.
