References are made to the joint announcement published by Tian An China Investments Company Limited and Asiasec Properties Limited (the “**Company**”) dated 23rd June, 2021 and the announcements of the Company dated 30th June, 2021 and 9th July, 2021 in relation to the Proposal made by TACI to the Company (the “**Announcements**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Announcements.

As disclosed in the announcement of the Company dated 9th July, 2021, a circular (the “**Circular**”) containing, among other things, (i) further information on the Proposal; (ii) a letter of advice from the IFA to the IBC and the Independent Shareholders; (iii) a letter of recommendation from the IBC to the Independent Shareholders; (iv) the property valuation report of the Proposed DF Group; and (v) a notice of the EGM, is expected to be despatched to the Shareholders on or before 30th July, 2021. However, as additional time is required for the Company to finalise certain information in the Circular, the Board expects the date of despatch of the Circular to the Shareholders will be delayed to a date falling on or before 31st August, 2021.
