The Company is making these arrangements with a view to protecting the environment and accordingly recommends that you elect to receive Corporate Communication(s) in electronic form on the Company’s website.

In that event, when the Company makes a Corporate Communication, it will only send to you notification that the Corporate Communication has been made available on the Company’s website.
