## **2. GENERAL INFORMATION**

The Company is a company incorporated in Hong Kong with limited liability, the shares of which are listed on the main board of the Stock Exchange (stock code: 392). The Company is an integrated public utilities company, underpinned by gas, water and environmental sectors as well as related upstream and downstream investments as its principal businesses, with the beer business as a complementary segment, forming a collaborative development layout.

Yanjing Huiquan is a company established in the PRC with limited liability, the shares of which are listed on the Shanghai Stock Exchange (stock code: 600573). Its principal business involves the manufacturing and sales of beer. As at 30 June 2026, the Company indirectly held approximately 57.40% equity interest in Beijing Yanjing Brewery Co., Ltd. through Beijing Yanjing Brewery Investment Co., Ltd.\* (北京燕京啤酒投資有限公司), in which the Company holds approximately 79.77% equity interest, and Beijing Yanjing Brewery Co., Ltd. directly held 50.08% equity interest in Yanjing Huiquan. Therefore, Yanjing Huiquan is an indirect non-wholly owned subsidiary of the Company.
