(b) at any local time between 12:00 noon and 4:30 p.m. on Friday, 10 October 2025. In such a case, the Closing Time will be extended to 4:30 p.m. on the next business day which does not have any of the above warnings in force at any time between 9:00 a.m. and 4:30 p.m.
