

Results Highlights

- 北京控股實現營業收入601.5億港元,同比增長25.5%
- Revenue amounted to HK\$ 60.15 billion, representing a yoy increase of 25.5 %
- 股東應佔溢利56.7億港元,同比增長17.3%
- Profit attributable to shareholders of the Company amounted to HK 5.67 billion, representing a yoy increase of 17.3%.
- 每股基本盈利達4.41港元,同比增长16.7%
- Basic earnings per share amounted to HK\$ 4.41, representing a yoy increase of 16.7%
- 董事局建議派發末期股息每股港幣65仙
- The Board of Directors proposed a final dividend of HK 65cents per share.




Results Highlights – Beijing Gas


營業收入 Revenue

<u>輸氣量 Gas</u> Transmission Volume







銷量 Sales Volume









- 2015年新增簽約垃圾處理規模1,600噸/日;
- In 2015, the new contracted capacity of waste treatment reached 1,600 tons/day
- 其中北控環保實現營業收入3.93億港元;實現經營利潤 9,511萬港元
- **BE Environment:** Revenue reached HK\$393 million, operating profit amounted to HK\$ 95.11 million in 2015
- 北京發展實現營業收入約12.5億港元,實現經營利潤約8,816 萬港元
- **Beijing Development:** Revenue reached HK\$1.25 billion, operating profit amounted to HK\$88.16 million in 2015





Business Updates – Beijing Gas



清洁空气行动计划 Clean Air Action Plan

- 2014年底投產之京西、高井及高安屯熱電中心運行穩定,加上2015年 年中投產之國華熱電廠進一步增加了天然氣的需求,燃氣發電售氣量穩 步上升
- The stable operation of the Jingxi, Gaojing and Gaoantun that commenced production at the end of 2014, and the Guohua plant that put into operation in mid-2015, further created the demand for natural gas and led to a steady increase in gas demand for power generation.
- 推進燃煤鍋爐清潔能源改造,全年完成174座约3,859蒸吨
- Accelerated the transformation of coal-fire boiler, with cumulative transformation volume of 3,859 t/h steam of 174 boilers till end of 2015
- 三聯供分佈式能源市場拓展效果顯著,京津冀周邊外埠市場陸續成功簽約新項目
- The expansion in tri-generation distributed energy market gave apparent effects, while the markets outside the surrounding Beijing-Tianjin-Hebei succeeded in signing new projects successively.

- Completed a sales volume of 168 million cubic meters, which had lowered the emission effectively.

- Completed the natural gas online trade with Shanghai Oil and Gas Trading Center for the first time

Beijing Development (Hong Kong) Limited

- Strengthen the operation and security management of the two existing solid waste projects in Tai An and Changde
- 繼續推進置出非主業資產,基本完成全部資訊業務的轉讓出售工作
- Actively moved forward the replacement of non-principal assets, and has now basically completed the transfer and disposition of the entire information technology business.
- 截至年底日處理垃圾實際規模達到1,550噸
- As at the end of 2015, the actual waste treatment capacity was 1,550 tons/day.
- 截至2015年底,北控環保及北京發展完成生活垃圾入廠量167.6萬噸,實現日均處理5,079噸,完成上網電量4.04億 kWh,完成危廢入廠量2.28萬噸。
- As at the end of 2015, BEHET and Beijing Development accomplished a household waste input volume of 1,676,000 tons with a daily treatment volume of 5,079 tons. It accomplished on-grid power generation volume of 404,000,000 KWH and hazardous waste input volume of 22,800 tons.

Business Updates – Major Capital Operation

- 2015年北京控股在境外完成融資合計約97.6億港元
- Total foreign financing completed by Beijing Enterprises in 2015 was approximately HK\$9,760 million
- 2015年4月,北京控股在境外成功發行5年期5億歐元債券融資
- In April 2015, Beijing Enterprises successfully issued the oversea financing of the 5-Year Euro 500 million bonds
- 首次實現中資企業以自身紅籌結構信用發行,為歐元債 奠定發行新標準
- As the first Chinese enterprise to issue bonds based on its red-chip structure creditability, BEHL established a new standard for Euro bonds issuance
- 2015年12月,北京控股成功發行25年期的2億美元債券,為公司主營業務發展再次提供了強大的資金支援
- In December 2015, the Company successfully issued the 25-Year US\$200 million bonds, which once again provided strong capital support for the development of the Company's major operations.



Business Updates – Implementation of Strategic Business Layout

- 2015年12月,北京控股已簽訂協議向北控水務注入 金州水務集團股份有限公司(「金州水務」)100%股 權。
- In December 2015, the Company entered into an agreement to inject the 100% equity interest of Golden State Water Group Corporation ("GSWG") into BE Water.
- 金州水務於中國江蘇、河南、上海及北京直接或間接持有十個水務項目,擁有設計總處理能力為1,711,000噸/日,其中已運營項目處理能力為1,154,000噸/日,在建項目處理能力500,000噸/日



- GSWG owns, directly or indirectly, ten water treatment projects in Jiangsu, Henan, Shanghai and Beijing, the PRC, with a total designed treatment capacity of 1,711,000 tons/day. Of which, the treatment capacity for projects under its operation is 1,154,000 tons/day and the treatment capacity for projects under construction is 500, 000 tons/day.
- 此次資產注入有待北控水務獨立股東的批准,符合北京控股之發展策略,並將於北控水務之現有資產產生 巨大的協同效應。
- Such asset injection, which is subject to the approval of independent shareholders of BE Water, is in line
 with the development strategy of the Company and will give a tremendous synergistic effect on the
 existing assets of BE Water.



收購The Acquisition

- 2016年3月2日,正式完成對德國EEW Energy from Waste GmbH ("EEW")廢物能源利用公司,現金代價為14.38億歐元
- 2 March 2016, finished the acquisition of EEW Energy from Waste GmbH ("EEW"), an energy-from-waste company in Germany, at a cash consideration of EUR1,438,000,000
- 必將大力提升北控在國內固廢環保領域的業務規模和行業地位
- Will improve BEHL's business scale and position in the domestic industry
- 將借助EEW的豐富經驗,環保理念、技術和管理經驗,努力提升國內的固廢及環保行業整體水平
- Leverage on its rich experience and advanced idea, technology and management experience, strive to enhance China's overall domestic standard in environmental protection industry





EEW 項目

- 總部位於德國之歐洲領先廢物能源利用公司,其主要業務為以廢物供電、供汽及供熱
- A leading energy-from-waste ("EfW") company in Europe headquartered in Germany, with its principal business in the supply of electricity, stream and heat from waste
- 營運位於德國及其毗鄰國家之18間廢物能源利用工廠之組合,並 於德國廢物能源利用業務擁有約17%之市場份額
- EEW Group operates a portfolio of 18 EfW plants located in Germany and neighbouring countries and accounted for approximately 17% market share of EfW business in Germany.
