# BEHL Receives "Energywi\$e Certificate" and "Wastewi\$e Certificate" from HKGOC for the First Time

(15 October 2024, Hong Kong) - Recently, Beijing Enterprises Holdings Limited ("BEHL" or the "Company"; stock code: 0392.HK) was awarded the "Energywi\$e Certificate" and the "Wastewi\$e Certificate" by Hong Kong Green Organisation Certification (HKGOC) for the first time, fully demonstrating the Company's outstanding contributions in promoting environmental protection, practicing green development, and fulfilling social responsibility.

The HKGOC is jointly led by organizations such as the Environmental and Ecology Bureau of the HKSAR Government, the Environmental Campaign Committee, the Hong Kong Council of Social Service, the Hong Kong General Chamber of Commerce, and the Hong Kong Productivity Council. The HKGOC aims to benchmark organizations in green management and encourage participating organizations to adopt environmental practices in aspects such as green waste reduction, energy conservation, carbon reduction, and IAQ improvement. Certified organizations can receive media coverage to showcase their outstanding green achievements, be invited to share their green achievements and experiences at public events, and be granted certificates and stickers to make the public aware of the organization's environmental contribution, further enhancing corporate brand image.

BEHL has actively responded to the national "dual-carbon" policy and has long adhered to its own sustainable development philosophy. It has issued initiatives to all employees at the Hong Kong headquarters to "Apply green practices in the office, save energy and improve efficiency" and "Oppose waste and cherish food". By displaying green waste reduction awareness posters in public areas, as well as promoting energy-saving and carbon-reduction practices during employee activities and similar events, BEHL encourages employees to turn off lights and equipment

when leaving the office, conserve paper and water resources, cherish food, and engage in the proper recycling of recyclables such as used bottles, and motivates them to start with small actions in their daily lives to contribute to Hong Kong's environmental protection efforts. Going forward, BEHL will maintain its adherence to the mission of "Prospering in Hong Kong and serving Beijing", fulfil its social responsibilities as a state-owned enterprise, and continue to take practical actions to protect the environment and give back to the society.
