**Letter to New Registered Shareholders**  
**- Election of Language and Means of Receipt of Corporate Communications**

Pursuant to Rule 2.07A(2A) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, we are writing to seek your election in relation to the following matters regarding the corporate communications (“Corporate Communication(s)”) of Bosideng International Holdings Limited (the “Company”) to be despatched in the future. You may choose:

- (1) to read future Corporate Communications published on the Company’s website ([company.bosideng.com](http://company.bosideng.com)) and the website of the HKExnews ([www.hkexnews.hk](http://www.hkexnews.hk)) (the “Website Version”) in place of receiving printed copies, and receive a printed notification letter of the publication of the Corporate Communications on the said websites; or
- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

You have the right at any time by reasonable notice in writing to the Company c/o the Hong Kong Share Registrar to change the choice of language and means of receipt of the Corporate Communications. You may also send such a notice by email to [bosideng@computershare.com.hk](mailto:bosideng@computershare.com.hk). Even if you have elected (or are deemed to have elected) to receive the Website Version but for any reason have difficulty in receiving or gaining access to the Website Version, the Company will upon your request send the Corporate Communications to you in printed form free of charge as soon as possible.
