Letter to New Registered Shareholders
- Election of Language and Means of Receipt of Corporate Communications

Pursuant to Rule 2.07A(2A) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, we are writing to seek your election in relation to the following matters regarding the corporate communications (“Corporate Communication(s)”) of Bosideng International Holdings Limited (the “Company”) to be despatched in the future. Corporate Communications include any document to be issued by the Company for your information or action, including but not limited to: (a) the directors’ report, its annual report together with a copy of the auditor’s report and, where applicable, its summary financial report; (b) its interim report and, where applicable, its summary interim report; (c) a notice of meeting; (d) a listing document; (e) a circular; and (f) a proxy form.

You may choose:

- (1) to read future Corporate Communications published on the Company’s website (<http://company.bosideng.com>) and the website of the HKExnews (www.hkexnews.hk) (the “Website Version”) in place of receiving printed copies, and receive a printed notification letter of the publication of the Corporate Communications on the said websites; or
- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

In support of environmental protection and for the purpose of saving printing and mailing costs, the Company recommends you to select the Website Version. If the Company does not receive a Reply Form or an objection from you by August 19, 2022 and until you inform the Company c/o the Company’s Hong Kong Branch Share Registrar by reasonable notice according to the relevant laws and regulations, you will be deemed to have elected the Website Version and we will only send you a printed notification of the publication of the Corporate Communications on the Company’s website and the website of the HKExnews in the future.

You have the right at any time by reasonable notice in writing to the Company c/o the Company’s Hong Kong Branch Share Registrar to change the choice of language and means of receipt of the Corporate Communications. You may also send such a notice by email to bosideng@computershare.com.hk. Even if you have elected (or are deemed to have elected) to receive the Website Version but for any reason have difficulty in receiving or gaining access to the Website Version, the Company’s Hong Kong Branch Share Registrar will upon your request send the Corporate Communications to you in printed form free of charge as soon as possible.
