POSITIVE PROFIT ALERT

This announcement is made by Capital Finance Holdings Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market (the “**GEM**”) of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board (the “**Board**”) of the directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors of the Company that, based on the information currently available to the Company and preliminary review of the unaudited consolidated management accounts of the Company and its subsidiaries (the “**Group**”), it is expected to record a profit attributable to owners of the Company for the nine months ended 30 September 2016 as compared to a loss attributable to owners of the Company of approximately HK\$264.2 million for the corresponding period in 2015 (the “**Expected Turnaround**”).

The Expected Turnaround was mainly attributable to no non-cash impairment loss on goodwill in relation to the short-term financing cash generating unit was recorded for the nine months ended 30 September 2016, while an impairment loss of approximately HK\$275.9 million was recorded for the nine months ended 30 September 2015.

As the Company is still in the process of finalising the third quarterly results of the Group for the nine months ended 30 September 2016, the information contained in this positive profit alert announcement is only based on the Company's preliminary assessment of the unaudited consolidated management accounts of the Group and information currently available to the Group. The third quarterly results of the Group for the nine months ended 30 September 2016 are not yet finalised nor reviewed by the audit committee of the Company. Further details of the Group's financial information for the nine months ended 30 September 2016 will be disclosed in the unaudited third quarterly results announcement, which are expected to be published on or around 11 November 2016.

The information contained in this announcement is only based on information currently available and the preliminary review by the Board. Shareholders and potential investors are therefore, advised to exercise caution when dealing in the shares of the Company.
