On 20 February 2019, the Company executed the Amendment Deeds to extend the maturity date of the 2014 Convertible Bonds by 3 years from 24 June 2019 to 24 June 2022, and the 2015 Convertible Bonds by 3 years from 5 February 2020 to 5 February 2023, in which are subject to independent shareholders' approval.
