

**NAME CHANGE**

The Board is pleased to announce that the English name of the Company has been changed from “Central Wealth Group Holdings Limited” to “Smart Fish Wealthlink Holdings Limited” and the secondary name of the Company in Chinese has been changed from “中達集團控股有限公司” to “小魚盈通控股有限公司”.

**CHANGES OF STOCK SHORT NAMES AND COMPANY WEBSITE**

Shares will be traded on the Stock Exchange under the new stock short name “SMART FISH” in English and “小魚盈通” in Chinese, with effect from 9:00 a.m. on 28 July 2025. The stock code of the Company will remain unchanged as “139”.

To reflect the Name Change, the official website of the Company has been changed to “www.139hk.com”.

Reference is made to the announcement of Smart Fish Wealthlink Holdings Limited (the “**Company**”) (formerly known as “Central Wealth Group Holdings Limited”) dated 22 May 2025 and the circular of the Company dated 28 May 2025 (the “**Circular**”) in relation to, among other matters, the proposed change of the English name and secondary name of the Company in Chinese. Unless otherwise defined, capitalized terms used in this announcement shall have the same meanings as those defined in the Circular.

## **NAME CHANGE**

At the SGM, a special resolution was passed for approving the change of the English name of the Company from “Central Wealth Group Holdings Limited” to “Smart Fish Wealthlink Holdings Limited” and the change of the secondary name of the Company in Chinese from “中達集團控股有限公司” to “小魚盈通控股有限公司”.

The Board is pleased to announce that the Certificate of Incorporation on Change of Name and the Certificate of Secondary Name were issued by the Registrar of Companies in Bermuda on 23 June 2025, certifying the change of the English name of the Company from “Central Wealth Group Holdings Limited” to “Smart Fish Wealthlink Holdings Limited”, and the change of the secondary name of the Company in Chinese from “中達集團控股有限公司” to “小魚盈通控股有限公司”. The Registrar of Companies in Hong Kong issued the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company on 11 July 2025, confirming the registration of the new names “Smart Fish Wealthlink Holdings Limited 小魚盈通控股有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

## **CHANGES OF STOCK SHORT NAMES AND COMPANY WEBSITE**

To reflect the Name Change, shares will be traded on the Stock Exchange under the new stock short name “SMART FISH” in English and “小魚盈通” in Chinese, instead of “CENTRALWEALTHGP” and “中達集團控股”, with effect from 9:00 a.m. on 28 July 2025. The stock code of the Company will remain unchanged as “139”.

The official website of the Company has been changed to “www.139hk.com”. Shareholders and investors can surf at the above website for the official information of the Company.

## **EFFECT OF THE NAME CHANGE**

The Name Change will not affect any rights of the Shareholders. The existing share certificates in issue bearing the former company name of “Central Wealth Group Holdings Limited 中達集團控股有限公司” will continue to be evidence of title to such securities and will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for free exchange of the existing share certificates of the Company for new share certificates bearing the new names of the Company.

New share certificates will be issued in the new names of the Company.
