POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 24 JUNE 2022

The Board is pleased to announce that all the resolutions as set out in the AGM Notice were duly passed by way of poll at the Annual General Meeting held on 24 June 2022.

Reference is made to the notice of the Annual General Meeting of China Chengtong Development Group Limited (“**Company**”) dated 1 June 2022 (“**AGM Notice**”) and the circular of the Company of even date (“**AGM Circular**”). Unless otherwise defined, terms used herein shall have the same meanings as those defined in the AGM Circular.

RESULTS OF THE ANNUAL GENERAL MEETING

The Annual General Meeting was held on 24 June 2022. As at the date of the Annual General Meeting, there were a total of 5,964,635,045 Shares in issue. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, no Shareholder was required under the Listing Rules to abstain from voting on the resolutions proposed at the Annual General Meeting. As such, there were a total of 5,964,635,045 Shares, representing 100% of the issued share capital of the Company as at the date of the Annual General Meeting, entitling Shareholders to attend and vote on the resolutions proposed at the Annual General Meeting. There were no Shares entitling the Shareholders to attend the Annual General Meeting and abstain from voting in favour of the resolutions proposed at the Annual General Meeting as set out in Rule 13.40 of the Listing Rules. None of the Shareholders has stated his/her/its intention in the AGM Circular to vote against the resolutions proposed or to abstain from voting at the Annual General Meeting. Computershare Hong Kong Investor Services Limited, the share registrar and transfer office of the Company, was appointed as the scrutineer at the Annual General Meeting for the purpose of vote-taking.
