**PROPOSED GRANTING OF GENERAL MANDATES TO REPURCHASE

1. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of the resolutions to be proposed at the Annual General Meeting for (i) the granting of the Repurchase Mandate, the Issue Mandate and the Extension Mandate to the Directors; and (ii) the re-election of the Directors, and to give you notice of the Annual General Meeting.

LETTER FROM THE BOARD

2. PROPOSED GRANTING OF GENERAL MANDATES

At the annual general meeting of the Company held on 16 June 2016, ordinary resolutions were passed to, among other things, grant the general mandates to the Directors (i) to repurchase Shares of an aggregate number of up to 10% of the number of Shares in issue on 16 June 2016; (ii) to allot, issue or otherwise deal with Shares of not exceeding 20% of the number of Shares in issue on 16 June 2016; and (iii) to extend the general mandate to allot and issue Shares by adding the number of repurchased Shares to the general mandate as mentioned in (ii) above.

As at the Latest Practicable Date, no Shares had been issued or repurchased pursuant to the general mandates granted to the Directors on 16 June 2016.

These general mandates will lapse at the conclusion of the Annual General Meeting.

Repurchase Mandate

At the Annual General Meeting, an ordinary resolution will be proposed in respect of the granting to the Directors of the Repurchase Mandate, in the terms set out in the notice of the Annual General Meeting, to repurchase Shares on the Stock Exchange or any other stock exchange on which the securities of the Company may be listed and which has been recognised by the SFC and the Stock Exchange of an aggregate number of up to 10% of the number of issued Shares as at the date of passing of the relevant resolution.

Issue Mandate

At the Annual General Meeting, an ordinary resolution will also be proposed to grant the Issue Mandate to the Directors to allot, issue or otherwise deal with Shares of not exceeding 20% of the number of issued Shares as at the date of passing of the relevant resolution, which is 1,161,746,955 Shares based on the total number of issued Shares as at the Latest Practicable Date and assuming that the number of issued Shares remains unchanged up to the date of the Annual General Meeting.

Extension Mandate

In addition, an ordinary resolution regarding the Extension Mandate will be proposed at the Annual General Meeting providing that any Shares repurchased under the Repurchase Mandate (up to a maximum of 10% of the number of issued Shares as at the date of the grant of the Repurchase Mandate) will be added to the total number of Shares which may be allotted and issued under the Issue Mandate.

LETTER FROM THE BOARD

The Repurchase Mandate and the Issue Mandate will continue in force until the conclusion of the next annual general meeting of the Company held after the Annual General Meeting or any earlier date as referred to in the proposed ordinary resolutions numbered 4 and 5 in the notice of the Annual General Meeting as set out on pages 11 to 15 of this circular. With reference to the Repurchase Mandate and the Issue Mandate, the Directors state that they have no immediate plan to repurchase or issue any Shares pursuant thereto.

In accordance with the requirements of the Listing Rules, the Company is required to send to the Shareholders an explanatory statement containing all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the granting of the Repurchase Mandate. The explanatory statement as required by the Listing Rules in connection with the Repurchase Mandate is set out in Appendix I to this circular.

3. RE-ELECTION OF DIRECTORS

In accordance with Article 105 of the Articles and in compliance with code provision A.4.2 of the Corporate Governance Code set out in Appendix 14 to the Listing Rules, Mr. Wang Tianlin and Professor Chang Qing will retire as Directors by rotation and shall be eligible for re-election at the Annual General Meeting. Each of Mr. Wang Tianlin and Professor Chang Qing being eligible, offers himself for re-election as a Director at the Annual General Meeting. Brief biographical details of them are set out in Appendix II to this circular.

4. ANNUAL GENERAL MEETING

The notice for the Annual General Meeting is contained in this circular and a form of proxy for use at the Annual General Meeting is enclosed with this circular. Whether or not you are able to attend the Annual General Meeting in person, you are requested to complete the accompanying form of proxy in accordance with the instructions printed thereon and return the same by 10:00 a.m. on Wednesday, 7 June 2017 or not later than 48 hours before the time appointed for holding any adjournment of the Annual General Meeting to the Company's share registrar and transfer office, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong. Completion and return of the form of proxy will not preclude you from attending and voting at the Annual General Meeting or any adjournment thereof should you so wish and, in such event, the form of proxy previously submitted shall be deemed to be revoked.

For determining the entitlement of the Shareholders to attend and vote at the Annual General Meeting, the register of members of the Company will be closed from Tuesday, 6 June 2017 to Friday, 9 June 2017 (both days inclusive) during which period no transfer of Shares will be effected. In order to be entitled to attend and vote at the Annual General Meeting, all completed share transfer documents, accompanied by the relevant share certificates, must be lodged with the Company's share registrar and transfer office, Computershare Hong Kong Investor Services Limited at the address mentioned above for registration no later than 4:30 p.m. on Monday, 5 June 2017.

If Typhoon Signal No. 8 or above or a Black Rainstorm Warning Signal is hoisted and is not lowered at or before 8:00 a.m. on the date of the Annual General Meeting, the Annual General Meeting will be postponed. The Company will publish an announcement on the websites of the Stock Exchange (www.hkex.com.hk) and of the Company (www.irasia.com/listco/hk/chengtong) to notify the Shareholders of the date, time and place of the rescheduled meeting.

No Shareholder is required to abstain from voting at the Annual General Meeting under the Listing Rules.

5. VOTING BY POLL

In compliance with the Listing Rules, all resolutions will be voted on by way of a poll at the Annual General Meeting. After the conclusion of the Annual General Meeting, the results of the poll will be published on the websites of the Stock Exchange (www.hkexnews.hk) and of the Company (www.irasia.com/listco/hk/chengtong).

6. RECOMMENDATION

The Directors consider that the grant of the Issue Mandate, the Repurchase Mandate and the Extension Mandate, and the re-election of Directors are all in the interests of the Company and the Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of all resolutions to be proposed at the Annual General Meeting.

7. RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief, the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

The following explanatory statement contains all the information required pursuant to Rule 10.06(1)(b) of the Listing Rules to enable the Shareholders to make an informed decision on whether to vote for or against the resolution to approve the grant of the Repurchase Mandate to the Directors.

1. LISTING RULES RELATING TO THE REPURCHASE OF SHARES

The Listing Rules allow companies whose primary listing is on the Stock Exchange to repurchase their shares on the Stock Exchange or any other stock exchange on which the securities of the company may be listed and which has been recognised by the SFC subject to certain restrictions. Among such restrictions, the Listing Rules provide that the shares of such company must be fully paid up and all repurchases of shares by such company must be approved in advance by passing an ordinary resolution at a general meeting, either by way of a general repurchase mandate or by specific approval granted to a particular transaction.

2. SHARE CAPITAL

As at the Latest Practicable Date, there were a total of 5,808,734,776 issued Shares.

Subject to the passing of the proposed resolution concerning the grant of the Repurchase Mandate and on the basis that no further Shares will be issued or repurchased prior to the Annual General Meeting, the Company will be allowed to repurchase up to 580,873,477 Shares under the Repurchase Mandate.

3. REASONS FOR THE REPURCHASE

The Directors believe that it is in the best interests of the Company and the Shareholders as a whole to seek a general authority from the Shareholders which enables the Company to repurchase the Shares on the Stock Exchange or any other stock exchange on which the Shares may be listed. Share repurchases may, depending on the then market conditions and funding arrangements, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders.

4. FUNDING OF REPURCHASES

Repurchases will be financed by the funds that are legally available for such purposes in accordance with the Articles and the laws of Hong Kong.

APPENDIX I EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

Taking into account the current working capital position of the Company, the Directors consider that, if the Repurchase Mandate were to be exercised in full, it might materially impact on the working capital and/or the gearing position of the Company as compared with the position as at 31 December 2016, being the date of its latest audited consolidated financial statements. However, the Directors do not intend to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing levels of the Company unless the Directors consider that such purchases are in the best interests of the Company and the Shareholders.

6. THE TAKEOVERS CODE AND MINIMUM PUBLIC FLOAT

If a Shareholder's proportionate interest in the voting rights of the Company increases as a result of the Company's exercising its powers to repurchase Shares pursuant to the Repurchase Mandate, such increase will be deemed as an acquisition for the purposes of the Takeovers Code. As such, a Shareholder or a group of Shareholders acting in concert (as defined under the Takeovers Code), depending on the level of increase in the Shareholders' interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, World Gain Holdings Limited, the Company's holding company, was interested in 2,980,876,119 Shares, representing approximately 51.32% of the total issued Shares of the Company. The entire issued share capital of World Gain Holdings Limited is beneficially owned by China Chengtong Hong Kong Company Limited ("CCHK"), which is wholly-owned by China Chengtong Holdings Group Limited ("CCHG"). On the basis that there will be no further issue or repurchase of Shares during the period from the Latest Practicable Date up to and including the date of the Annual General Meeting, the beneficial interests of World Gain Holdings Limited in the issued Shares of the Company would be increased to approximately 57.02% if the Repurchase Mandate were exercised in full. The Directors are not aware of any consequence which may arise under the Takeovers Code as a result of any repurchase of Shares made under the Repurchase Mandate, nor do the Directors intend to exercise the Repurchase Mandate in full.

In the event that the Repurchase Mandate were exercised in full, the number of Shares held by the public would not fall below 25%.

7. SHARE REPURCHASES BY THE COMPANY

The Company did not purchase any of the Shares (whether on the Stock Exchange or otherwise) in the six months immediately preceding the Latest Practicable Date.

8. GENERAL

None of the Directors nor (to the best of their knowledge having made all reasonable enquiries) any of their close associates (as defined in the Listing Rules) currently intend to sell any Shares to the Company if the Repurchase Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange that, so far as relevant rules are applicable, they will only exercise the power of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of Hong Kong.

No core connected person (as defined in the Listing Rules) of the Company has notified the Company of his/her/its present intention to sell any Shares to the Company nor has any such core connected person undertaken not to sell any Shares held by him/her/it to the Company in the event that the Repurchase Mandate is granted.

The biographical details and other particulars of the Directors who will retire at the Annual General Meeting and will offer themselves for re-election thereat according to the Articles are set out below:

MR. WANG TIANLIN, AGED 44, EXECUTIVE DIRECTOR**Length of service and remuneration**

Mr. Wang joined the Group in February 2007 and was appointed as an executive Director on 1 September 2009. Mr. Wang has signed a service contract with a specific term of one year with the Company but is subject to retirement by rotation and re-election pursuant to the Articles. Pursuant to his service contract, Mr. Wang is entitled to receive a monthly payment of HK\$20,000 as his director's fee, plus a monthly salary which is currently in the amount of HK\$41,296.50 and a discretionary performance-based bonus. His remuneration is determined in accordance with his duties and market conditions and the Group's profit benchmark.

Mr. Wang is currently also a director of certain wholly-owned subsidiaries of the Company. Save as aforesaid, Mr. Wang did not hold any other position in the Company and other members of the Group as at the Latest Practicable Date.

Qualification and experience

Mr. Wang obtained his bachelor and master degrees from Beijing Institute of Technology. He obtained his master degree in Business Administration in Finance from The Chinese University of Hong Kong in 2003. Mr. Wang has extensive experience in corporate governance, capital management and business administration. He was previously the secretary to the board of directors of Sihuan Pharmaceutical Company Limited whose shares are listed on the Shenzhen Stock Exchange, and was also the assistant to president for CCHK. Mr. Wang did not hold any directorship in other listed companies in the last three years.

Interests in shares, underlying shares or debentures

As at the Latest Practicable Date, Mr. Wang had a personal interest in 400,000 Shares awarded pursuant to the share award scheme of the Company adopted on 25 April 2012, representing 0.0069% of the total issued share capital of the Company. Other than the said interest, Mr. Wang was not interested or deemed to be interested in any other shares, underlying shares or debentures of the Company or its associated corporations within the meaning of Part XV of the SFO.

Relationship

Mr. Wang is currently a president and executive director of China Huandao Group Co., a subsidiary of CCHG. Save as disclosed herein, Mr. Wang did not have any relationship with any other Director, senior management, substantial Shareholders (as defined in the Listing Rules) or controlling Shareholder (as defined in Listing Rules).

Others

Mr. Wang does not have any information which is required to be disclosed under Rule 13.51(2)(h) to (v) of the Listing Rules. Save as disclosed herein, there are no other matters in relation to his re-election that need to be brought to the attention of the Shareholders.

PROFESSOR CHANG QING, AGED 59, INDEPENDENT NON-EXECUTIVE DIRECTOR**Length of service and remuneration**

Professor Chang joined the Group as an independent non-executive Director in January 2013. He has signed a service contract with a specific term of one year with the Company but is subject to retirement by rotation and re-election pursuant to the Articles. Pursuant to his service contract, Professor Chang is entitled to receive a monthly payment of HK\$30,000 as his director's fee. The director's fee is determined in accordance with his duties and market conditions.

Professor Chang was also the chairman of the nomination committee of the Company and a member of the audit committee of the Company. Save as aforesaid, Professor Chang did not hold any other position in the Company and other members of the Group as at the Latest Practicable Date.

Qualification and experience

Professor Chang studied Economics at Jilin University and obtained his master degree in Economics from Jilin University in 1985 and PhD degree from Chinese Academy of Social Sciences. He has over 30 years of experience in economic and financial field. He is currently the chairman of Jinpeng International Futures Co., Ltd., a professor of China Agricultural University and the chairman of the expert committee of China Futures Association. Professor Chang is also currently a council member of Shanghai Futures Exchange and a member of the Expert Committee of China Securities Journal. Professor Chang is now acting as an independent non-executive director of Kangda International Environmental Company Limited (a company listed on the Main Board of the Stock Exchange). He previously served as independent director of Tibet Summit Resources Co., Ltd. (formerly known as Tibet Summit Industry Co., Ltd.) and TBEA Co., Ltd. (both companies are listed on the Shanghai Stock Exchange) as well as Yuan Long Ping High-Tech Agriculture Co., Ltd., Rongfeng Holding Group Co., Ltd. and Shenwu Environmental Technology Co., Ltd. (all three companies are listed on the Shenzhen Stock Exchange). Save as aforesaid, Professor Chang did not hold any directorship in other listed companies in the last three years.

Interests in shares, underlying shares or debentures

As at the Latest Practicable Date, Professor Chang was not interested or deemed to be interested in any shares, underlying shares or debentures of the Company or its associated corporations within the meaning of Part XV of the SFO.

Relationship

Professor Chang did not have any relationship with any other Director, senior management, substantial Shareholder (as defined in the Listing Rules) or controlling Shareholder (as defined in the Listing Rules) of the Company.
