

# CHAIRPERSON'S STATEMENT 主席報告



Dear shareholders,

On behalf of China New City Commercial Development Limited ("Company") and its subsidiaries (collectively, the "Group"), I submit herewith the results of the Group for the year ended 31 December 2021.

2021 had been the second year since the outbreak of Covid-19, social development and macroeconomic were subject to many uncertainties as well as significant challenges. As pointed out in the Report on the Work of the Government published in March 2021, the Covid-19 pandemic continued to spread rapidly around the world, while factors contributing to instability in international relations were mounting, as the global economic landscape remained complex with austere conditions. Domestically, there were still occasional weak links in our work to control Covid-19. The foundation of economic recovery had yet to be strengthened, while investment growth lacked sustainability, leaving MSMEs and individual proprietors in tough business conditions. For some local governments which faced glaring budgetary deficits, the task of preventing and mitigating financial and other risks remained an enormous one. Such complex economic and social environment called for versatility and precision in macroeconomic and other policies. The macroeconomy was experiencing downturn pressure as a result of the impacts of scattered Covid-19 outbreaks, floods and other natural disaster occurring in various regions as well as restrictions on production activities and electricity supply.

#### 致各位股東:

本人謹代表中國新城市商業發展有限公司(「本公司」)及其附屬公司(統稱「本集團」)提呈本集團截至2021年12月31日止年度之業績。

2021年已是新冠肺炎疫情爆發的第二年,社會發展和宏觀經濟面臨諸多不確定性和重大挑戰。 2021年3月的《政府工作報告》指出,新冠肺炎疫情仍在全球迅速蔓延,國際形勢中不穩定因素增多,世界經濟形勢複雜嚴峻。國內疫情防控仍偶有薄弱環節,經濟恢復基礎不算牢固,投資增長後勁不足,中小微企業和個體商戶困難較多。一些地方財政收支矛盾突出,防範化解金融等領域風險任務依然艱巨。錯綜複雜的經濟和社會環境下,宏觀經濟等政策更需要靈活多變、精準出擊。在疫情零散出現、洪澇災害多地出現、限產限電等因素的衝擊下,宏觀經濟面臨下行壓力。

#### **MARKET**

Since August, there had been significant changes in real estate policies following the collapse of certain real estate enterprises and the rapid, continuous cooling of the real estate market. Such changes were underpinned primarily by the concern for the financial risks of real estate enterprises and the tightening of mortgage lending, among others. In the third quarter, the intertwined and combined impact of the epidemic and the change in real estate policies adversely affected deployment and operation of the Group's commercial projects. To address the severe market conditions, the Group actively responded to the austerity by speeding up the destocking of inventory properties and cash recovery to ensure the security of funds.

#### 市場

從8月份以來,受到部分房企爆雷、房地產市場快速且持續降溫等影響,房地產政策出現重要變化,主要體現在對房企金融風險的關注、對房貸投放的收緊等。於三季度,疫情以及房地產政策變化的不利影響交織,並疊加傳導至本集團商業項目佈局及運營。面對嚴峻的市場形式,本集團積極應對寒冬,加快存量物業的去化和現金回籠,保證資金安全。



#### COMMERCIAL

In terms of commercial operation, following the launch of our commercial brand under the theme of "Blooming (綻放)", the Group launched the brand of "Pleasant Living for All (眾享生活)" in the year to focus on the operation of future communities, as it seized the favorable opportunity presented by Zhejiang Province's vigorous effort to build a future community and persisted in the integration of construction and operation from the building of houses to the building of cities in tandem with latest developments. Currently, the brand has officially entered into strategic media cooperation agreements with a number of channels and websites, as well as strategic industry alliances for cooperation with research institutes. In the future, the business segment and the "Pleasant Living for All (眾享生活)" brand will expand and strengthen this new business model on the back of three future communities, including Sha Bei in Taizhou, Longgang in Wenzhou and Kegiao in Shaoxing, with the aim of assisting Zhejiang Province in the creation of an exemplary zone for common prosperity and the securing of preemptive opportunities for development.

#### 商業

在商業運營方面,繼以「綻放」為主題的商業品牌發佈會後,本集團在年度緊緊抓住浙江省全力建設未來社區的有利契機,順應時代發展,堅持建設運營一體化,從造房到造城,發佈「眾享生活」品牌,專注未來社區運營。目前,該品牌已分別與多條頻道及網站正式簽訂了戰略媒體合作協議;與研究院達成了產業戰略聯盟合作。未來,商業板塊及「眾享生活」品牌將依託台州沙北、溫州龍港、紹興柯橋三個未來社區,做大做強這一新商業模式,助力浙江省創建共同富裕示範區,贏得發展先機。



Apart from breakthroughs in the new business models, continued conversion, improvement and innovation have also been made in the existing business under the commercial segment. Highlong Plaza has been officially renamed as Xiaoshan Zhong An Plaza and is set for blooming development in four aspects: a new positioning, new image, new trademark and new business. The first local cultural trademark in Xiaoshan will be introduced to investigate the feasibility of developing an immersive and experiential shopping centre that would more properly cater to the habits and needs of local consumers as a masterpiece commercial property in Xiaoshan.

除了在新商業模取得突破外,商業板塊對已有商業也在持續不斷的改造、提升以及創新。恆隆廣場已正式更名為蕭山眾安廣場,將從新定位、新形象、新商標、新業態四個方面煥新綻放,並引入蕭山首個在地文化商標,探索沉浸式、體驗式購物中心,更好的迎合當地消費者的習慣和需求,打造蕭山商業的扛鼎之作。

In the future, we need to create a successful template of future communities and seize opportunities. Based on the existing future community projects, we will establish Zhong An's brand and industry position in respect of the development and operation of future communities. We will transform the traditional business model of department store into a fast-selling-oriented, experiential and leisurely business model with business resource reserve and form unique trademark resources focusing on the principle of "Small brand, light investment, fast development".

我們未來需要打造未來社區成功模板,抓住契機,基於現有未來社區項目,樹立眾安在未來社區開發運營的品牌和行業地位;改造傳統百貨業態,注重快銷型、體驗型、休閒型的業態導入和商業資源儲備,圍繞「小品牌,輕投入,快發展」的原則,形成獨有的商標資源。

#### HOTEL

# As for the hotel operations, despite the considerable impact of epidemic outbreaks in the first three quarters on the industry, we remained a leader among our competition in terms of indicators such as consolidated revenue, occupancy rate and average room prices thanks to the diligent efforts of the hotel team. Meanwhile, our hotels actively pursued internal improvement during the epidemic by comprehensively enhancing the "craft quality" and "craftsmanship" of Bright Hotel through vocational skill competitions and the building of a 4D management system. In July 2021, the hotel was honoured with the 2021 China Best Hotel Group Employer (2021年度中國最佳酒店集團僱主獎) at the China Hotel Forum & Menduner Awards (門墩兒酒店業高峯論壇暨"門墩兒"獎頒獎典禮).

#### 酒店

在酒店運營方面,前三季度疫情仍舊對行業造成了不小的衝擊,但在酒店團隊的努力之下,綜合營收、出租率、平均房價等各項指標均處於競爭圈內領先地位。同時,酒店在疫情期間積極修煉內功,通過開展職業技能大賽和4D管理體系建設全面提升伯瑞特酒店的「匠心品質」和「匠人精神」。2021年7月,酒店在門墩兒酒店業高峰論壇暨「門墩兒」獎頒獎典禮上,榮獲2021年度中國最佳酒店集團僱主獎。

In the future, we need to create an upstream and downstream integrated management ecological chain with hotel as the core and realize resource complementation and mutual sharing to create marginal benefits. Meanwhile, we will enhance hotel themes and features to implement differentiated market operation philosophy. With different themes, we will create different closed loop of consumption ecology and realize diversified operation. We must strengthen our catering operation capability. With traditional culture and traditional craftsmanship as the core of the cuisine, we will develop the catering business into one of the foundations of the hotel's brand and upgrade the overall operational efficiency of the hotels.

我們未來需要打造上下游一體化經營生態鏈,以 酒店為中心,形成上下游一體化經營生態鏈,實 現資源互補互享,增加邊際效益。同時加強酒店 主題和特色打造,形成差異化市場經營理念,不 同的主題,打造不同的消費生態閉環,實現多元 化經營。必需提升餐飲經營能力:以傳統文化、 傳統工藝為菜系核心,切實將餐飲成為酒店品牌 的基礎之一,提升酒店整體的經營效益。

#### **RESULTS**

In 2021, the Group recorded an increase in revenue and the capital structure was optimized. During the year, the Group's revenue was approximately RMB871,066,000, representing a year-on-year increase of approximately 24.3%; gross profit was approximately RMB216,497,000, representing a year-on-year increase of approximately 27.2%; loss attributable to owners of the Company was approximately RMB295,136,000. As at the end of 2021, the total equity of the Group was approximately RMB5,733,595,000, representing a slight decrease of approximately 5.7% from the end of 2020; the carrying amount of cash reached approximately RMB1,948,034,000. During the year, the Group's cash position and gearing ratio had both improved and with the "Three Red Line" ratios had all been satisfactorily met.

The Group recorded a loss per share attributable to ordinary equity holders of the parent of approximately RMB14.7 cents. The board of directors (the "**Board**") of the Company does not recommend the payment of any final dividend for the year under review.

#### **PROSPECTS**

In 2022, it is expected that the principle of "safeguarding the healthy development of the real estate market as well as the legitimate rights of home buyers" will be implemented in a more effective manner. There should be further improvements to the delivery assurance policies of local governments, and it is more likely that pre-sale proceeds will be subject to stringent supervision with some latitude for slight adjustments, such that a new balance between ensuring property delivery and improvement of corporate capital utilisation efficiency could be attained. Meanwhile, the Group will look for possible investment opportunities in China or overseas to diversify the income source and risk exposure of the Group. The Board will continue to closely monitor the potential impact caused by the COVID-19 pandemic and will fine-tune the Group's strategies and inform the shareholders and the public of any material development in due course.

#### 業績

2021年,本集團錄得收入增加,且資本結構得以優化。年內,本集團收入約為人民幣871,066,000元,同比增加約24.3%;毛利約為人民幣216,497,000元,同比增加約27.2%;本公司擁有人應佔虧損約為人民幣295,136,000元。於2021年底,本集團總權益約為人民幣5,733,595,000元,較2020年底略微減少約5.7%;現金賬面值約為人民幣1,948,034,000元。年內,本集團的現金狀況及負債比率均得到改善,而「三條紅線」比例亦已達致滿意水平。

本集團錄得母公司普通股權益持有人應佔每股虧損約為人民幣14.7分。本公司董事會(「董事會」)不建議派發回顧年度末期股息。

#### 前景

2022年,本集團預計「維護房地產市場的健康發展,維護住房消費者的合法權益」將得到更好地貫徹落實,各地保交付政策或將進一步完善,預售資金監管嚴中微調的可能性更大,在保交樓與提高企業資金使用效率方面尋求新的平衡。集團同時將尋求中國或海外的可能投資機會,以多元化發展本集團的收入來源及分散所承受的風險。董事會將繼續密切監察COVID-19疫情所造成的潛在影響,並將調節本集團的策略,並於適當時候知會股東及公眾人士有關任何重大發展。

## MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論與分析

#### **REVIEW OF 2021**

In 2021, China's real estate market experienced the structural transition from extremely heated sentiments during the first six months to fundamental corrections in the latter half of the year; nevertheless, a relatively large market size was retained for the year as a whole. The effect of ongoing modifications and upgrades in the regulation policy introduced in the real estate market during the first three guarters has been evident.

A "two-way" mode for property market regulation was implemented throughout the year. In some cities where property price levels were more resilient, regulatory policies swiftly responded to sharp rise in prices with the introduction of effective tools such as the establishment of a mechanism for the publication of referential prices for second-hand housing transactions and credit tightening etc. For other cities where the real estate market was under greater pressure in price correction, moderate policy adjustments were made to stabilize market expectations.

In 2021, the Group's revenue recorded an increase and the capital structure was optimized. During the year, the Group's revenue was approximately RMB871,066,000, representing a year-on-year increase of approximately 24.3%; gross profit was approximately RMB216,497,000, representing a year-on-year increase of approximately 27.2%; net loss attributable to owners of the Company was approximately RMB295,136,000. As of the end of 2021, the total equity of the Group reached approximately RMB5,733,595,000, representing a slight decrease of approximately 5.7% from the end of 2020; the carrying amount of cash reached approximately RMB1,948,034,000.

#### **OUTLOOK FOR 2022**

In terms of macroeconomics, a trend of steady recovery will continue in the Chinese economy, although there will also be new challenges and obstacles due to the increasing instability and uncertainties in both the domestic and international environments. It is expected that the principle of "safeguarding the healthy development of the real estate market as well as the legitimate rights of home buyers" will be implemented in a more effective manner. There should be further improvements to the delivery assurance policies of local governments and it is more likely that pre-sale proceeds will be subject to stringent supervision with some latitude for slight adjustments, such that a new balance between ensuring property delivery and improvement of corporate capital utilisation efficiency could be attained.

#### 回顧2021

2021年,中國房地產市場經歷了從上半年高熱 到下半年深度調整的轉變,全年規模仍保持較高 水平。前三季度,房地產市場調控政策不斷完善 升級,政策效果亦較為明顯。

樓市「雙向」調節模式或貫穿全年,部分房價韌性較強的城市,若市場出現明顯升溫,調控政策亦將迅速跟進,建立二手房成交參考價格發布機制、收緊信貸等政策均為有效工具;而部分房地產市場調整壓力較大的城市,亦將適度調整政策穩定市場預期。

2021年,本集團的收入錄得增加,且資本結構得以優化。年內,本集團收入約為人民幣871,066,000元,同比增加約24.3%;毛利約為人民幣216,497,000元,同比增加約27.2%;本公司擁有人應佔虧損約為人民幣295,136,000元。截至2021年底,本集團總權益約為人民幣5,733,595,000元,較2020年底略微減少約5.7%;現金賬面值約為人民幣1,948,034,000元。

#### 展望2022

宏觀經濟方面,2022年,我國經濟或延續穩步恢復態勢,但國內外環境中不穩定不確定因素增多,我國經濟仍面臨新的挑戰和下行壓力。預計「維護房地產市場的健康發展,維護住房消費者的合法權益」將得到更好地貫徹落實,各地保交付政策或將進一步完善,預售資金監管嚴中微調的可能性更大,在保交樓與提高企業資金使用效率方面尋求新的平衡。

In general, it is expected that the overall direction for the regulation of the real estate industry will remain unchanged, and the rigour of financial supervision will not be relaxed. Policies such as the "Three Red Lines" for enterprises, the "Two Red Lines" for banks, and the "Two Concentrations" for land supply will continue to be implemented. Currently, the real estate market has entered a phase of correction, and there will be increasing mergers and acquisitions in the industry. Against this backdrop, real estate companies should more than ever control their scale of development and adjust their pace in tandem with the market trend in 2022: they should accelerate the collection of sales proceeds and closely monitor financing windows to ensure cash flow security; they should plan their expenditure in a manner commensurate with their income and optimize their business presence to focus on mainstream cities; they should improve their product and service capabilities to improve brand competitiveness. Furthermore, new development opportunities may arise during the stage of industry correction. Private enterprises should look to cooperate with state-owned enterprises to broaden their scope of development.

整體來看,預計房地產行業調控總基調將保持不變,金融監管力度不會放鬆,企業端「三道紅線」、銀行端「兩條紅線」、土地「兩集中」等政策仍將繼續執行。當前房地產市場已步入調整通道,行業收並購將增加。在此背景下,2022年房企更需順勢而為,控規模、調節奏:加速銷售回款,緊盯融資窗口期,確保現金流安全;量入為出,優化城市佈局,聚焦主流城市;提升產品力和服務力,提高品牌競爭力。此外,在行業調整階段,或將迎來新的發展機遇,民企或可尋求與國企合作機會,更好地拓展發展空間。

#### **DEVELOPMENT OF MAJOR PROJECTS**

#### Hangzhou, Zhejiang Province

#### **Fashion Color City**

It is located in Xinjie Village, Xiaoshan District, Hangzhou. It consists of hardcover loft apartments, large apartments and shops, with a total floor area of approximately 26,087 sq.m. and a total GFA of approximately 78,261 sq.m., and is for commercial use. The project commenced construction in the third quarter of 2020 and started the pre-sale in the fourth quarter of 2020. It is expected to be completed in 2022. The volume of pre-sales of the project during the year under review was within expectation.

#### **International Office Centre (IOC)**

IOC is a large-scale integrated commercial complex located in Qianjiang Century City (錢江世紀城), Xiaoshan District, Hangzhou, comprising serviced apartments, shopping malls and offices. The total site area of Plot A is 92,610 sq.m. and planned total GFA is 798,795 sq.m.. The project is constructed in three phases, consists of Plots A1, A2 and A3. Among which, Plot A3 was completed in 2015, comprising serviced apartments, shops and underground parking spaces with a total GFA of approximately 327,996 sq.m.. The construction of Plot A2 has commenced in 2019 with a total GFA of approximately 263,555 sq.m.. The project started the pre-sales in the third quarter of 2020, and is expected to be completed in 2022. The volume of pre-sales of the project during the year under review was within expectation.

#### 浙江省杭州市

#### 明彩城

位於杭州市蕭山區新街村,由精裝loft公寓、大平層公寓及商鋪組成,總佔地面積約為26,087平方米,總建築面積約為78,261平方米,作商業用途。該項目於2020年第三季度開工,並於2020年第四季度啟動預售。預計與2022年竣工。於回顧年度,該項目預售符合預期。

#### 國際辦公中心(IOC)

位於杭州蕭山區錢江世紀城的大型商業綜合體,包括服務式住宅、商場及辦公室。項目A地塊總佔地面積為92,610平方米,預計總建築面積為798,795平方米。該項目分三期建設(A1地塊、A2地塊及A3地塊),其中A3地塊已經於2015年竣工,包括服務式公寓、商鋪及地下停車場,總建築面積約為327,996平方米。A2地塊已於2019年開工,總建築面積約為263,555平方米,並於2020年第三季度啟動預售,預計與2022年竣工。於回顧年度,該項目預售符合預期。

#### MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論與分析

#### **Beigan Project**

It is located in Beigan Technology Innovation Park, Xiaoshan District, Hangzhou, and consists of large flats and shops, with a total floor area of approximately 12,819 sq.m., and a total GFA of approximately 44,867 sq.m., and is for commercial use. The project commenced construction in the fourth quarter of 2021 and is expected to start the pre-sale in the second quarter of 2022 and is expected to be completed in 2024.

#### **Cixi New City**

This is a residential property project in Cixi, Zhejiang Province. Commercial Phase 1, with a total GFA of about 28,158 sq.m., commenced construction in July 2019, started the pre-sale in the third quarter of 2020, and completed in 2021. Commercial Phase II, with a total GFA of about 72,000 sq.m., commenced construction in the second quarter of 2021, and is expected to be completed in 2023.

#### **Sales Review**

For the year ended 31 December 2021 (the "Year"), the recognized sales of properties sold and delivered was approximately RMB410,180,000 (2020: approximately RMB248,942,000). A total of the recognized GFA delivered of properties was approximately 26,994 sq.m..

#### 北幹項目

位於杭州市蕭山區北幹科創園地塊,由大平層及商鋪組成,總佔地面積約12,819平方米,總建築面積約44,867平方米,作商業用途。該項目於2021年第四季度開工,預期於2022年第二季度啟動預售,於2024年竣工。

位於浙江省慈溪市的商業地產項目。商業一期,總建築面積約28,158平方米,於2019年7月開工,並於2020年第三季度啟動預售,2021年已竣工。商業二期,總建築面積約72,000平方米,於2021年第二季度開工,預期於2023年竣工。

#### MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論與分析

#### **Hotel Operation**

There are four hotels of the Group namely Holiday Inn Hangzhou Xiaoshan, Qiandao Lake Bright Resort Hotel, Ningbo Bright Hotel and Huaibei Bright Hotel. The hotel operation of the Group recorded a revenue of approximately RMB173,177,000 (2020: approximately RMB182,516,000), representing a decrease of approximately 5.1%, during the Year and the hotel occupancy rate was approximately 40% (2020: approximately 43%).

#### **Leasing Business**

The leasing income of the Group mainly comes from Highlong Plaza, International Office Centre and Zhong An Times Square, including office and shopping malls. The total revenue from leasing business for the Year was approximately RMB122,282,000, representing a decrease of approximately RMB22,563,000 (2020: approximately RMB144,845,000). The decline was due to the renovation of the Highlong Plaza and the average occupancy rate of leasing properties (calculated by dividing total lease area by total area available for lease) was approximately 87% (2020: approximately 94%).

#### **Land Reserve**

As of 31 December 2021, the total GFA of land reserves held for development and/or sale of the Group was approximately 4,069,165 sq.m..

#### **REVENUE**

The Group recorded the consolidated revenue of approximately RMB871,066,000 for the Year, representing an increase of approximately RMB170,696,000 or 24.4% when compared with the same year in 2020. The increase was mainly due to the increase in the revenue from the property sales.

#### 酒店營運

本集團現有四間酒店,即杭州蕭山假日酒店、杭州千島湖伯瑞特度假酒店、寧波伯瑞特酒店及淮北伯瑞特酒店。於本年度內,本集團酒店營運錄得收入約人民幣173,177,000元(2020年:約人民幣182,516,000元),減少約5.1%,酒店入住率約達40%(2020年:約43%)。

#### 租賃業務

本集團的租金收入,主要來自恒隆廣場、國際辦公中心及眾安時代廣場,包括寫字樓和購物商場。於本年度內,來自租賃業務之總收入約人民幣122,282,000元,減少約人民幣22,563,000元(2020年:約人民幣144,845,000元)。減少乃由於裝修恒隆廣場所致,而出租物業之平均出租率(按總出租面積除以總可租面積計算)則約達87%(2020年:約94%)。

#### 土地儲備

截至2021年12月31日,本集團持作發展及/或 銷售的土地儲備之總建築面積約為4,069,165平 方米。

#### 收入

本集團於本年度錄得綜合收入約為人民幣 871,066,000元,較2020年增加約人民幣170,696,000 元或24.4%。增加乃主要由於物業銷售增加所 致。 The revenue from the property sales increased to approximately RMB410,180,000 during the Year, representing an increase of approximately RMB161,238,000 or 64.8% when compared with the same year in 2020. The increase was mainly due to the fact that the impact of the Covid-19 epidemic had subsided in the Mainland China during 2021 which led to an increase in the property sales.

於本年度內,物業銷售收入增加至約人民幣 410,180,000元,較2020年增加約人民幣161,238,000 元或64.8%。有關增加乃主要由於2021年 Covid-19疫情於中國大陸的影響趨於平緩,令房 地產銷售增加所致。

The revenue from the property rental amounted to approximately RMB122,282,000 during the Year, representing a decrease of approximately RMB22,563,000 or 15.6% when compared with the same year in 2020. The decline was due to the renovation of the Highlong Plaza, which involved merchants' exemptions, relocation and store closure etc., which led to the lower average occupancy rate of leasing properties in the Year.

於本年度內,物業租賃收入約為人民幣122,282,000元,較2020年減少約人民幣22,563,000元或15.6%。有關減少乃由於本年度裝修恒隆廣場涉及商戶豁免、搬遷及關閉商店等,令出租物業之平均出租率下跌所致。

The revenue from the hotel operation amounted to approximately RMB173,177,000 during the Year, representing an decrease of approximately RMB9,339,000 or 5.1% when compared with the same year in 2020. The moderate decrease was mainly due to the mild drop of the hotel occupancy rate.

於本年度內,酒店營運收入約為人民幣173,177,000元,較2020年減少約人民幣9,339,000元或5.1%。有關溫和減少乃主要由於酒店入住率輕微下跌所致。

The other revenue included property management services business, commercial project management business and other services of RMB165,427,000, representing an increase of approximately RMB41,360,000 or 33.3% when compared with the same year in 2020.

其他收入亦包括物業管理服務業務、商業項目管理業務及其他服務人民幣165,427,000元,較2020年增加約人民幣41,360,000元或33,3%。

#### **GROSS PROFIT**

#### 毛利

The gross profit of the Group for the Year amounted to approximately RMB216,497,000, representing an increase of approximately RMB46,342,000 or 27.2% when compared with the same year in 2020. The gross profit margin was 24.9%, no significant movement when compared with the gross profit margin of 24.3% in 2020.

於本年度內,本集團的毛利約為人民幣216,497,000元,較2020年增加約人民幣46,342,000元或27.2%。毛利率為24.9%,與2020年的毛利率24.3%比較並無重大變化。

#### OTHER INCOME AND GAINS, NET

The other income and gains, net amounted to approximately RMB374,689,000 during the Year, representing a tangible increase of approximately RMB188,024,000 or 100.7% when compared with the same year in 2020. The increase was mainly due to the receipt of compensation income from a legal case, an increase in interest income, gain on disposal of subsidiaries, gain on disposal of right-of-use assets and dividend income from equity investments.

## SELLING AND DISTRIBUTION EXPENSES

The selling and distribution expenses amounted to approximately RMB182,698,000 during the Year, representing an increase of approximately RMB18,395,000 or 11.2% when compared with the same year in 2020. Such increase was principally due to an increase in advertising and promotional activities for the properties pre-sold during the Year when compared with the same year in 2020.

#### **ADMINISTRATIVE EXPENSES**

The administrative expenses amounted to approximately RMB249,476,000 during the Year, representing an increase of approximately RMB48,452,000 or 24.1% when compared with the same year in 2020. Such increase was principally due to an increase in administrative staff for new projects deployed.

#### **OTHER EXPENSES**

The other expenses amounted to approximately RMB151,826,000 during the Year, mainly representing the impairment of goodwill of RMB98,995,000 and impairment provision for property and equipment of RMB11,436,000 as resulted from a business revaluation of the parent-child family club, Maggie & Rose.

#### **FINANCE COSTS**

The finance costs of the Group amounted to approximately RMB223,094,000 for the Year, representing an increase of approximately RMB3,897,000 or 1.8% when compared with the same year in 2020. Such increase was mainly due to less interests on bank loans and other commercial borrowings for completed properties were capitalized during the Year.

#### 其他收入及收益淨額

於本年度內,其他收入及收益淨額約為人民幣374,689,000元,較2020年實質增加約人民幣188,024,000元或100.7%。增加乃主要由於收取法律案件的賠償收入、利息收入增加、出售附屬公司的收益、出售使用權資產的收益以及股權投資的股息收入所致。

#### 銷售及分銷開支

於本年度內,銷售及分銷開支約為人民幣182,698,000元,較2020年增加約人民幣18,395,000元或11.2%。有關增加乃主要由於本年度預售物業的廣告及推廣活動較2020年增加所致。

#### 行政開支

於本年度內,行政開支約為人民幣249,476,000元,較2020年增加約人民幣48,452,000元或24.1%。 有關增加主要由於已開展新項目增聘行政員工 所致。

#### 其他開支

於本年度內,其他開支約為人民幣151,826,000元,主要為親子家庭俱樂部Maggie & Rose的業務重新估值產生的商譽減值人民幣98,995,000元以及物業及設備的減值撥備人民幣11,436,000元。

#### 財務費用

於本年度內,本集團之財務費用約為人民幣 223,094,000元,較2020年增加約人民幣3,897,000 元或1.8%。有關增加主要由於本年度的銀行貸款 利息減少及已竣工物業的其他商業借貸資本化所 致。

#### LOSS FOR THE YEAR

The loss attributable to the Group was approximately RMB302,815,000 for the Year, comparing with a net profit of approximately RMB25,081,000 in 2020, such loss for the Year was mainly due to the fact the Group recorded a fair value gain upon transfer to investment properties in the amount of approximately RMB356,806,000 during 2020 which was not available in the Year 2021.

#### **CAPITAL EXPENDITURE**

The Group's capital expenditure requirements mainly relate to additions of its property and equipment. The Group spent approximately RMB118,941,000 on property and equipment during the Year.

#### SIGNIFICANT INVESTMENTS

The Group did not hold any significant investments during the Year.

#### **DISPOSALS OF SUBSIDIARIES**

On 3 February 2021, the Group had entered into sale and purchase agreements with Zhong An Group to agree conditionally to sell the entire operation in commercial property management business at an aggregate of consideration of RMB104.65 million (equivalent to approximately HK\$125.58 million) ("**Transfers**").

As Zhong An Group is the controlling shareholder of the Group, Zhong An Group is a connected person of the Group. As one or more of the relevant percentage ratios (as defined under the Listing Rules) in respect of the Transfers exceeded 5%, the Transfers constituted non-exempt connected transactions for the Group under the Listing Rules and were subject to the reporting, announcement and approval by the independent shareholders under Chapter 14A of the Listing Rules. An extraordinary general meeting had been held on 24 March 2021 to approve the Transfers. The completion of the Transfers took place on 13 April, 2021.

#### 本年度虧損

於本年度內,本集團應佔虧損約為人民幣302,815,000元,而2020年則為淨溢利約人民幣25,081,000元,本年度的有關虧損主要由於本集團於2020年錄得轉撥至投資物業之公允價值收益約人民幣356,806,000元,而2021年度則並無錄得有關收益所致。

#### 資本開支

本集團的資本開支需要主要與添置物業及設備 有關。於本年度內,本集團於物業及設備耗用約 人民幣118,941,000元。

#### 重大投資

於本年度內,本集團並無持有任何重大投資。

#### 出售附屬公司

於2021年2月3日,本集團已與眾安集團訂立買賣協議,以有條件同意按總代價人民幣104,650,000元(相當於約125,580,000港元)出售商業物業管理業務的全部業務(「轉讓事項」)。

由於眾安集團為本集團的控股股東,故眾安集團 為本集團的關連人士。由於轉讓事項的一項或多 項相關百分比率(定義見上市規則)超過5%,根 據上市規則,轉讓事項構成本集團的非豁免關連 交易,須遵守上市規則第14A章項下報告、公告 及獨立股東批准的規定。本公司已於2021年3月 24日舉行股東特別大會以批准轉讓事項。轉讓事 項已於2021年4月13日完成。

#### CAPITAL STRUCTURE

As at 31 December 2021, the Group had aggregate cash and cash equivalents and restricted cash of approximately RMB1,948,034,000 (as at 31 December 2020: approximately RMB1,108,888,000). The current ratio (as measured by current assets to current liabilities) as at 31 December 2021 was 1.05 (as at 31 December 2020: 1.69).

As at 31 December 2021, the bank loans and other borrowings of the Group repayable within one year and after one year were approximately RMB1,527,310,000 and approximately RMB3,107,940,000 respectively (as at 31 December 2020: approximately RMB665,555,000 and approximately RMB4,803,094,000 respectively). Except for certain short-term bank and other borrowings amounting to approximately RMB2,384,950,000 (as at 31 December 2020: approximately RMB854,120,000) that bear interest at fixed rates, all bank loans bear interest at floating rates.

As at 31 December 2021, the Group's gearing ratio was 42% (as at 31 December 2020: 49%), which is net debt divided by capital plus net debt. Net debt includes interest-bearing bank and other borrowings, trade payables, other payables and accruals, and lease liabilities, less cash and cash equivalents. Capital represents equity attributable to owners of the parent.

#### 資本結構

於2021年12月31日,本集團的現金及現金等價物及受限制現金總額約為人民幣1,948,034,000元(於2020年12月31日:約人民幣1,108,888,000元)。於2021年12月31日的流動比率(按流動資產除以流動負債計算)為1.05(於2020年12月31日:1.69)。

於2021年12月31日,本集團須於一年期內償還及一年後償還的銀行貸款及其他借款分別為約人民幣1,527,310,000元及約人民幣3,107,940,000元(於2020年12月31日:分別為約人民幣665,555,000元及約人民幣4,803,094,000元)。除若干按固定利率計息之短期銀行及其他借款約人民幣2,384,950,000元(於2020年12月31日:約人民幣854,120,000元)外,所有銀行貸款按浮動利率計息。

於2021年12月31日,本集團之資本負債比率為42%(於2020年12月31日:49%),有關比率按債務淨額除以資本加債務淨額計算。債務淨額包括計息銀行及其他借款、應付貿易賬款、其他應付款項及應計費用以及租賃負債,減現金及現金等價物。資本為母公司擁有人應佔權益。

#### TREASURY POLICIES

The Group principally operates in PRC and the revenue, operating cost and borrowings were mainly denominated in RMB. As a result, the Group has minimal exposure to exchange rate fluctuation. The interest rates for the Group's borrowings were both floating and fixed. Upward fluctuations in interest rates will increase the cost of borrowings.

The Group adopts conservative treasury policies in cash and financial management. Cash is generally placed in short-term deposits mostly denominated in RMB. The Group does not use any financial instruments for hedging purpose for the Year.

## GUARANTEES AND CONTINGENT LIABILITIES

As at 31 December 2021, the Group's contingent liabilities was approximately RMB316,410,000 (2020: approximately RMB46,656,000), which were mainly the guarantees provided by the Group in favour of certain banks for the grant of mortgage loans to purchasers of the Group's properties.

#### 庫務政策

由於本集團主要在中國經營業務,而收入、經營 成本及借款主要以人民幣計值,故本集團所承擔 之匯率波動風險甚微。本集團借款利率為浮動及 固定。利率向上波動將增加借款成本。

本集團在現金及財務管理方面採取審慎庫務政策。現金通常會存作短期存款,大部份以人民幣 為單位。本集團於年內並無使用任何金融工具作 對沖用途。

#### 擔保及或有負債

於2021年12月31日,本集團或有負債約為人民幣316,410,000元(2020年:約人民幣46,656,000元),主要為本集團就若干銀行向本集團物業的買家授出的按揭貸款出具的擔保。

#### **CAPITAL COMMITMENTS**

As at 31 December 2021, the Group's capital commitments for property development expenditures amounted to approximately RMB1,330,123,000 (2020: approximately RMB1,001,730,000). It is expected that the Group will finance such capital commitments from its own funds and bank loans.

## FUTURE PLANS FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS

Save as disclosed in this report, the Group did not have other plans for material investments and capital assets as at 31 December 2021.

As at 31 December 2021, the Group had 1,630 employees (2020: 1,729). The employees' remuneration policy was determined by reference to factors such as remuneration information in respect of the local market, the overall remuneration standard in the industry, inflation level, corporate operating efficiency and performance of the employees. The Group conducts performance appraisal once every year for its employees, the results of which are applied in annual salary review and promotion assessment. The Group's employees are considered for the entitlement of annual bonus according to certain performance conditions and appraisal results. The Group also provides continuous learning and training programmes to its employees to enhance their skills and knowledge, so as to maintain and enhance their competitiveness.

#### **STRATEGIES**

The management has developed sound strategies to overcome the abovementioned challenges and address the uncertainties faced by the Group, including formulating effective marketing strategies and plans and improving our products and services quality to consolidate our brand. The Group will put more efforts in formulating new policies, guidelines, systems and processes to facilitate effectively cost management, risk management, internal control and sustainable environmental management to enhance company management standards and corporate governance standards. For growth strategy, the Group will focus on identifying possible acquisitions with future development prospects and profitability to improve the returns on assets. The Group will further emphasize on investor relations management, and continue to convey clearly the operation vision, business updates and future development strategies of the Group and other information to various stakeholders through press conferences, roadshows, media delegation visits and one-on-one analyst or investor interview and otherwise to strive for the recognition and support from various stakeholders and obtain more resources for business development and maximizing shareholders' value.

Our dedicated sales team constantly communicates with our customers and potential customers to uncover and create customer needs and help customers make informed decisions. Grasping the market trend is the key for the Group to timely adjust our operating strategies to meet the market demands.

The Company's policies and practices highlight the importance of compliance with all relevant local laws, rules, regulations and standard. This in return, facilitates the continuous granting of specific licenses and permissions.

The Group will seek professional legal advice from legal advisers, where necessary, to ensure transactions and business to be performed by the Group are in compliance with the applicable laws and regulations.

No material accidents related to serious injuries, death or property damage and no environmental claims, lawsuits, penalties or administrative sanctions were reported to our management during the year under review and as at the date of this annual report. The management is of the view that the Group were in compliance with all relevant PRC laws and regulations in each material respects.


The Board will review the corporate governance structure of the Group from time to time and will adopt appropriate measures as may be desirable for future development of the operating activities or business of the Group.

#### **BOARD OF DIRECTORS**

The Board comprises: (i) executive directors: Mr. Shi Nanlu, Mr. Liu Bo and Ms. Tang Yiyan; (ii) non-executive directors: Mr. Shi Zhongan and Mr. Tang Min; and (iii) independent non-executive directors: Mr. Ng Sze Yuen, Terry, Mr. Xu Chengfa and Mr. Yim Chun Leung.

The details of the Directors are set out in the section headed "Biographical Details of Directors and Senior Management" on pages 57 to 60 in this annual report. There are no relationships (including financial, business, family or other material/relevant relationships) among members of the Board. A list of the Directors identifying their roles and functions are available on the websites of the Company and the Stock Exchange.

The Company has received from each of its independent non-executive Directors an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules. The Board considers that all the independent non-executive Directors are independent in accordance with the guidelines set out in Rule 3.13 of the Listing Rules.

During the year under review, the Board meets regularly to discuss the overall strategy, the operational and financial performance of the Group. The Directors can attend meetings in person or through other electronic means of communication in accordance with the articles of association of the Company ("Articles").

#### **Chairperson and Chief Executive Officer**

The roles of the chairperson and chief executive officer are separate and are not performed by the same individual as this ensures better checks and balances and hence better corporate governance. During the year under review and as at the date of this report, the role of the chairperson was performed by Mr. Shi Zhongan, while Mr. Shi Nanlu was chief executive officer of the Group.

The chairperson had held a meeting with all independent non-executive Directors in the absence of executive Directors. No specific or other issues had been raised or discussed as it had been concluded that all issues which would be discussed had been properly dealt with in the meetings of the Board.

#### 主席及行政總裁

#### Non-Executive Director and Independent Non-Executive Directors

The non-executive Director, Mr. Shi Zhongan, has been appointed for a term of 3 years commencing on 31 May 2014, which is automatically renewable for a successive term of one year from the next day upon the expiry of the appointment.

The non-executive Director, Mr. Tang Min, has been appointed for a term of 3 years commencing on 3 April 2020, which is automatically renewable for a successive term of one year from the next day upon the expiry of the appointment.

The independent non-executive Directors, Mr. Ng Sze Yuen, Terry, Mr. Xu Chengfa and Mr. Yim Chun Leung, have been appointed for a term of 3 years commencing on 31 May 2014, which is automatically renewable for a successive term of one year from the next day upon the expiry of the appointment.

All non-executive Director and independent non-executive directors possess extensive academic, professional and/or industry expertise and management experience and have provided their professional advice to the Board.

#### Power of and Delegation by the Board

The Board operates and exercises its power in accordance with the Articles. The Board focuses on overall corporate strategies and policies with emphasis on the business growth, financial performance and corporate governance standard of the Group. It also decides on matters such as annual and interim results, major transactions, director appointments or re-appointments, investment policy, dividend and accounting policies and responsible for developing, reviewing and monitoring the policies and practices on corporate governance and legal and regulatory compliance of the Group. In addition, the Board has also specifically resolved that all transactions/contracts/other matters of the Group that are subject to the disclosure requirement in accordance with the Listing Rules should be approved by the Board in advance.

The Board has delegated to the senior management to deal with day-to-day operations and reviewed those arrangements on a periodic basis. The senior management frequently reports back to the Board and obtains prior approval from the Board before making decisions for key matters or entering into any commitments on behalf of the Company.

所有非執行董事及獨立非執行董事均擁有廣泛 的學術、專業及/或行業專長以及管理經驗,並 已向董事會提供專業意見。

#### 董事會權力及授權

董事會按照細則運用及行使其權力。董事會專注於整體企業策略及政策,尤其關注本集團的業務增長、財務表現及企業管治標準。其亦就年度及中期業績、主要交易、委任及續聘董事、投資政策、股息及會計政策等事宜作出決定,並負責制定、檢討及監察本集團的企業管治政策及慣例與遵守法律及法規情況。此外,董事會亦已特別議決,本集團按照上市規則受披露規定所規限的所有交易/合同/其他事宜應由董事會事先批准。

董事會委以高級管理層職能處理日常營運事宜, 並定期檢討該等安排。高級管理層於作出有關主 要事項的決策或代表本公司訂立任何承擔之前 須先向董事會匯報及獲得事先批准。

## Appointment, Re-election and Removal of Directors

The Articles provide that any Director appointed by the Board to fill a casual vacancy in the Board or as an additional member of the Board shall hold office only until the next following general meeting of the members of Company and shall then be eligible for re-election at such meeting.

In accordance with the Articles, at each AGM, one third of the Directors for the time being, shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years and, being eligible, offer themselves for re-election. The Company may, at any general meetings convened and held in accordance with the Articles, remove a Director by ordinary resolution at any time before the expiration of his period of office notwithstanding anything contrary in the Articles or in any agreement between the Company and such Director and may by ordinary resolution elect another person in his/her stead.

#### **BOARD COMMITTEES**

The Board has established four committees and has delegated various responsibilities to the committees, including the remuneration committee (the "Remuneration Committee"), the nomination committee (the "Nomination Committee"), the audit committee (the "Audit Committee") and the corporate governance committee (the "Corporate Governance Committee") of the Company. All the Board committees perform their distinct roles in accordance with their respective terms of reference which are available for inspection by the Shareholders on the websites of the Company and the Stock Exchange. The Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expense.

#### 董事之委任、重選及罷免

根據細則,於每屆股東週年大會上,佔當時董事人數三分之一之董事須輪席告退,惟各董事(包括以指定任期委任之董事)須最少每三年輪席告退一次,屆時均符合資格並願意應選連任。本公司可於按照細則召開及舉行的任何股東大會上以普通決議案隨時罷免一名任期並未屆滿的董事,而不論細則或本公司與該名董事之間訂立之任何協議有相反規定,彼等亦可以普通決議案選舉另一名人士代替其職位。

#### 董事會委員會

#### (i) Remuneration Committee

The Remuneration Committee comprises a total of three members, being one executive Director, Ms. Tang Yiyan, and two independent non-executive Directors, Mr. Xu Chengfa (chairperson of the Remuneration Committee) and Mr. Yim Chun Leung.

The Company has adopted written terms of reference for the Remuneration Committee. The role and function of the Remuneration Committee of the Company include the following:

- to make recommendations to the Board on the Company's policy and structure for all remuneration of Directors and senior management and on the establishment of a formal and transparent procedure for developing remuneration policy;
- (b) to make recommendations to the Board on the remuneration packages of individual executive Directors and senior management, including benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment, and make recommendations to the Board on the remuneration of non-executive Directors:
- to review and approve the management's remuneration proposals with reference to the Board's corporate goals and objectives;
- (d) to review and approve the compensation payable to executive Directors and senior management in connection with any loss or termination of their office or appointment to ensure that such compensation is determined in accordance with relevant contractual terms and that such compensation is otherwise fair and not excessive;

The Audit Committee comprises a total of three members, being three independent non-executive Directors, Mr. Ng Sze Yuen Terry (chairperson of the Audit Committee), Mr. Xu Chengfa and Mr. Yim Chun Leung. Mr. Ng Sze Yuen possess the appropriate professional qualification, and accounting and financial management expertise.

# RISK MANAGEMENT AND INTERNAL CONTROL SYSTEM

The Group recognizes that good risk management is essential for the long-term and sustainable growth of a business. The Board puts particular emphasis on determining the risk-tolerance levels in achieving the Group's strategic objectives and is responsible for the risk management and internal control systems and reviewing their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. The management also learns from other outstanding companies and takes into consideration of the Company's unique business and operating environment in formulating the risk management and control framework. All employees are committed to continually enhancing the risk management framework, linking to our corporate strategies as well as integrating it into day-to-day operation.

本集團確認良好風險管理對業務之長期可持續發展至關重要。董事會於達致本集團之策略目標時尤其著重釐定風險承受能力以及負責風險管理和內部監控系統及審查其有效性。該等系統百在管理而不是消除未能實現業務目標的風險,並且只能提供合理而不是絕對的保證來防止重大的錯報或損失。管理層於制定風險管理及監控架構時亦借鑒其他優秀公司之經驗及考慮本公司之獨特營商環境。所有僱員均致力不斷優化風險管理框架,將風險管理貫徹到企業策略及日常營運中。

# Objective of the Risk Management and Internal Control

The objectives of the risk management and internal control framework of the Group include:

- to strengthen the Company's risk management and internal control in compliance with the Listing Rules requirement;
- to establish and constantly improve the risk management and internal control system;
- to implement a top-down and companywide risk management system that covers every aspect of the business; and
- to keep baseline risks within the acceptable range.



# Main Features of Risk Management System – Three-tier Risk Management Approach

The Group has adopted a three-tier risk management approach to identify, assess, mitigate and handle significant risks. At the first line of protection, business units are responsible for identifying, assessing and monitoring risks associated with each business or deal. The management, as the second line of defense, defines rule sets and models, provide technical support, develops new systems and oversees portfolio management. It ensures risks are within the acceptable range and that the first line of protection is effective. As the final line of protection, the internal audit department ensures that the first and second lines of protection are effective through constant inspection and monitoring.

### 風險管理系統主要特點—三級風險管 理方法

# **Main Features of Internal Control System**

Our internal control systems are developed with reference to the Committee of Sponsoring Organizations of the Treadway Commission principles which involved five elements as internal environment, risk assessment, control activities, information and communication and internal supervision. The aim of internal control is to reasonably guarantee the compliance of its operation and management with regulations and laws, assets security, and authenticity and integrity of financial report and related information, improve the efficiency and effect of operating activities and promote the realization of development strategy of the Group.

### 內部監控系統主要特點

本集團之內部監控系統乃參照美國反虛假財務報告委員會發起人委員會(Committee of Sponsoring Organizations of the Treadway Commission)原則制定,其涉及內部環境、風險評估、監控活動、資訊及溝通以及內部監督等五項要素。內部監控旨在合理保證公司經營管理合規合法、資產安全、財務報告及相關資料真實完整,提高經營活動之效率及效果,促進本集團實現發展策略。



### **Principal Risks and Key Controls**

#### 1. Market risks

The Group's revenue is mainly derived from customers from PRC. The Group is exposed to the risks associated with the PRC market which include the risks of policy change, interest rate change, demand-supply imbalance and the overall economic conditions. The market risks may pose an adverse impact on the Group's business, financial condition or results of operations.

### 主要風險及關鍵監控

#### 1. 市場風險

本集團之收入主要來自中國客戶。本集團 面臨與中國市場有關之風險,其包括政策 變動、利率變動、供求失衡及整體經濟狀 況之風險。市場風險可能會對本集團之業 務、財務狀況或經營業績造成不利影響。 The project team will carefully scrutinize each project for related risks and returns. These include assessment of relevant government policies, market demand and conditions and economic data. The management is responsible for supervision, conducting regular operation reviews and keeping the Board fully informed through regular reports, and prompt decisions can therefore be made if changes are required.

#### 2. Business and operational risks

Distinctive risks factors in property related businesses such as default of buyers, tenants and strategic business partners, and inadequacies or failures of internal processes, people and systems may have different levels of negative impact on the results of the Group's operation. Industrial accidents may happen although precautionary measures is established, which may damage the Company's reputation or cause financial loss to the Group.

The internal audit team will review key activities of the Group and ensures all material controls, including financial and operational, are functioning effectively. Precautionary and contingency measures are also set up to ensure the Group is protected against major potential loss, damage or impact to our operations. Insurance coverage against accidental losses and/or other hazards is used in protecting our assets and reputation against any potential liabilities.

### 3. Financial risks

The investment and business operation are exposed to risks from exchange rates, interest rates and liquidity. Amid global financial uncertainties, the financial risks encountered by the Group had increased accordingly.

The Group closely monitors the financial risks and when appropriate will adopt measures to manage and hedge corresponding risks by using of derivatives such as interest rate and currency swaps. The Group's cash and financing are centrally managed and controlled at the corporate level to achieve a better borrowing terms and coherent financial risk management. To meet our obligations as and when needed, the Group maintains sufficient facilities with various banks and financial institutions. The maturity of deposits and loans is carefully planned and managed to reduce liquidity risk.

#### 2. 業務及營運風險

物業相關業務之獨有風險因素,如買家、租戶及策略性商業夥伴之違約,以及內部流程、人員及系統不足或失效,可能會對本集團之經營業績造成不同程度之負面影響。儘管採取預防措施,惟仍可能發生工業事故,從而可能損害本公司之聲譽或導致本集團產生財務虧損。

內部審核團隊將檢討本集團之主要活動並確保所有重大監控(包括財務及營運監控)有效運作。本集團亦已制定預防及應急措施以確保本集團之營運免遭重大潛在虧損、損害或影響。本集團已針對事故損失及/或其他危害投購保險,藉以保障本集團之資產及聲譽免受任何潛在責任之影響。

#### 3. 財務風險

投資及業務營運面臨匯率、利率及流動資金之風險。在全球金融尚不明朗之情況下,本集團面臨之財務風險相應上升。

本集團密切監控財務風險,並將於適當時候採取措施,透過使用衍生工具(如利率及貨幣掉期)以管理及對沖相應風險。本集團之現金及融資乃於公司層面集中管理及監控以達致更佳之借貸條款及貫徹一致之財務風險管理。為履行本集團之所需責任,本集團於多間銀行及金融機構備存充足融資額度。本集團審慎計劃及管理存款及貸款之到期日以降低流動資金風險。

### CORPORATE GOVERNANCE REPORT 企業管治報告

#### 4. Talent risks

Talent shortage and high employee turnover will have a negative impact on the Group's present and future performance. We believe that human resources are of critical importance for the success of the Company.

To attract, motivate and retain talented employees, the Group evaluate our employee remuneration packages and monitor them against market trends. We provide on-the-job training for new staff and offer career advancement opportunities for suitable staff to develop their full potential at various stages of their career. We also encourage communication with all levels of staff to gather feedback and suggestions for future improvement.

### **Review of Internal Control System**

The internal audit department of the Company ("Internal Audit Department") in the year under review was responsible for the internal control functions. The Internal Audit Department is required to provide internal control assessment reports to the Audit Committee and the Board on a regular or ad hoc basis.

The Board recognized its responsibility to ensure the Group maintains a sound and effective risk management and internal control system. The Directors had conducted a review of the effectiveness of the system of internal control of the Group during the Year. Such review had covered all material controls including financial, operational and compliance controls and risk management functions. No major issue but areas for improvement have been identified. The Board and the Audit Committee considered that the key areas of the Group's internal control systems are reasonably implemented.

#### 4. 人才風險

人才短缺及僱員高流失率將對本集團之現 時及未來表現造成負面影響。我們相信人 力資源對本公司的成功至關重要。

### 內部監控系統之檢討

董事會確認其確保本集團維持健全有效風險管理及內部監控系統的責任。董事已於年內對本集團內部監控系統的有效性進行檢討。有關檢討涵蓋所有重要的監控範疇,包括財務、營運及合規監控以及風險管理職能。概無發現重大事項,惟已識別需改進範疇。董事會及審核委員會認為本集團已合理實施內部監控系統的主要部份。

# HANDLING AND DISSEMINATION OF INSIDE INFORMATION

The procedures and internal controls for the handling and dissemination of inside information are as follows:

- the Group conducts its affairs with close regard to the disclosure requirement under the Listing Rules as well as the "Guidelines on Disclosure of Inside Information" published by the Securities and Future Commission in June 2012;
- the Group has implemented and disclosed its policy on fair disclosure by pursuing broad, non-exclusive distribution of information to the public through channels such as financial reporting, public announcements and its website;
- the Group has strictly prohibited unauthorized use of confidential or inside information;
- the Group has established and implemented procedures for responding to external enquiries about the Group's affairs, so that only the executive Directors of the Company, company secretary and investor relations officers are authorized to communicate with parties outside the Group; and
- employees or Directors possessing inside information should report the same to an executive Director, who will then report to the Board. The Board will then discuss and handle the relevant disclosures or dissemination of inside information accordingly.

### **COMPANY SECRETARY**

The appointment and removal of the Company Secretary is subject to the Board's approval in accordance with the articles of association of the Company.

The Company Secretary is responsible for advising the Board through the chairperson and/or the chief executive officer on governance matters and assisting the Board in discharging its obligations to Shareholders pursuant to the Listing Rules. He is also responsible for ensuring that the activities of the Board conducted efficiently and effectively, and procedures and all applicable laws and regulations complied with, and facilitating induction and professional developments of the Directors, the company secretary has taken no less than 15 hours of relevant professional training.

### **Financial Reporting**

The Directors acknowledge that they are responsible for the preparation of accounts which give a true and fair view of the Group. The Company has selected appropriate accounting policies and has applied them consistently based on prudent and reasonable judgments and estimates.

During the year under review, all Directors have been given on a quarterly basis the latest information report about the financial position and business development of the Group. The Directors endeavor to ensure a balanced and understandable assessment of the Company's position and prospects in annual reports, interim reports, inside information announcements and other disclosures required under the Listing Rules and other statutory requirements.

The statement of the auditor of the Company about its reporting responsibilities on the accounts of the Group is set out in the section headed "Independent Auditor's Report" in this annual report.

# OPERATION OF MEETING AND SUPPLY OF AND ACCESS TO INFORMATION

Notice of at least 14 days should be given of a regular board meeting to give all directors an opportunity to attend. For all other board meetings, reasonable notice should be given.

Board or committee papers will as far as practicable be sent to all Directors at least three days before the intended date of a Board meeting or a Board committee meeting.

Management has supplied the Board and its committees with adequate information and explanations so as to enable them to make an informed assessment of the information put before the Board and its Board committees for approval. Management is also invited to join the Board or Board committee meetings where appropriate.

Draft and final version of minutes of the meetings should be sent to all Board and Board committee members for their comment and records. Minutes of the meetings are kept by our Company Secretary, and the Board and Board committee members may inspect the documents and minutes of the Board and the Board committees at any time.

### **AUDITOR'S REMUNERATION**

The audit fee of the Group in respect of audit services provided by the independent auditor, Ernst & Young, for the Year was RMB1,680,000 (2020: RMB1,700,000).

During the year under review, the independent auditor was also engaged to review the interim results of the Company at a fee of RMB420,000 (2020: RMB300,000) and no other non-audit services took place (2020: Nii).

### NON-COMPETE UNDERTAKINGS

Each of the controlling shareholders and the Company entered into the Amended Non-Compete Undertakings to amend the Existing Non-Compete Undertakings, which will supersede and replace in its entirety the Existing Non-Compete Undertakings. In summary, pursuant to the Amended Non-Compete Undertakings, any member of the Zhong An Group will be entitled to be engaged in property management business (including but not limited to residential, commercial or mixed commercial-residential use properties and related ancillary services and for the avoidance of doubt, does not include operations and management of hotel and cinema) in the PRC, and the Group will no longer be engaged in any property management business (excluding operations and management of hotel and cinema) in the PRC. Please refer to the circular dated 5 March 2021 for details.

# DIRECTORS' AND OFFICERS' INSURANCE

The Company had arranged liability insurance for Directors and senior management officers of the Company with appropriate coverage in respect of legal action against them arising from their duties performed.

# MECHANISM FOR THE PROPERTY DEVELOPMENT ON MIXED-USE LANDS

In relation to the mechanism for the property development on Mixeduse Lands (as defined in the prospectus of the Company dated 16 June 2014 ("Prospectus")), each of Zhong An together with its subsidiaries, (the "Zhong An Group") and the Company has undertaken to each other that it must, in respect of each of its financial year ending after the Listing, instruct its auditor or independent financial advisers to review such documents as the auditor or independent financial advisers may require and confirm to its board of directors that the mechanism set out the section headed "Relationship with our Controlling Shareholders -Joint property development on mixed commercial-residential use land projects" in the Prospectus had been complied with during such financial year. During the year under review, the Directors confirm that there has not been any occasion where an opportunity aroused for an acquisition and development of land for property development project on mixed commercial-residential use land projects in which the remaining Zhong An Group (i.e. Zhong An Group, excluding the Group) (the "Remaining Zhong An Group") has invited the Group to participate in the Joint Development (as defined in the Prospectus).

# DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted a code of conduct regarding the Directors' securities transactions on terms no less exacting than the required standard set out in the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") set out in Appendix 10 to the Listing Rules.

Having made specific enquiry of all Directors, all Directors have confirmed that they have complied with the required standard set out in the Model Code and the Company's code of conduct during the year under review.

Senior management who, because of their office in the Group, are likely to be in possession of inside information, have also been requested to comply with the provisions of the Model Code when dealing in the Company's shares.

## SHAREHOLDERS' RIGHTS

# Convening Extraordinary General Meeting and Putting Forward Proposals at Shareholders' Meetings

Pursuant to article 64 of the Articles, general meetings shall be convened on the written requisition of any two or more Shareholders made to Directors or the Secretary specifying the objects of the meeting, provided that such requisitionists held as at the date of deposit of the requisition shall not hold less than one-tenth of the paid up capital of the Company which carries the right of voting at general meetings of the Company. If the Board does not within 21 days from the date of deposit of the requisition proceed duly to convene the meeting to be held within a further 21 days, the requisitionist(s) themselves may convene the general meeting in the same manner, as nearly as possible, as that in which meetings may be convened by the Board and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to them by the Company.

# Procedures for Proposing a Person for Election as a Director

If a shareholder, who is entitled to attend and vote at the relevant general meeting, wishes to nominate a person (not being the nominating shareholder) to stand for election as a Director, he or she should give to the company secretary of the Company notice in writing of the intention to propose a person for election as a Director and notice in writing by that person of his or her willingness to be so elected, no earlier than the 7 clear days after the dispatch of the notice of the relevant general meeting and no later than 7 clear days prior to the date appointed for the relevant general meeting.

Detailed procedures for Shareholders to propose a person for election as a Director are available on the Company's website.

Given that the Directors are entitled to determine any performance targets to be achieved as well as the minimum period that an option must be held before an option can be exercised on a case by case basis, and that the exercise price of an option cannot in any event fall below the price stipulated in the Listing Rules or such higher price as may be fixed by the Directors, it is expected that grantees of an option will make an effort to contribute to the development of the Group so as to bring about an increased market price of the Shares in order to capitalise on the benefits of the options granted.

The Board may, at its absolute discretion, invite any person belonging to any of the following classes of participants, to take up options to subscribe for Shares:

- (a) any employee (whether full-time or part-time including any executive Director but excluding any non-executive Director) of the Company, any of the Company's subsidiaries or any entity ("Invested Entity") in which any member of the Group holds an equity interest;
- (b) any non-executive Directors (including independent nonexecutive Directors) of the Company, any of the Company's subsidiaries or any Invested Entity;

and, for the purposes of the Scheme, the offer for the grant of option may be made to any company wholly owned by one or more persons belonging to any of the above classes of participants.

For avoidance of doubt, the grant of any options by the Company for the subscription of Shares or other securities of the Group to any person who falls within any of the above classes of participants shall not, by itself, unless the Board otherwise determine, be construed as a grant of option under the Scheme.

# 3. Maximum number of the Shares available for Subscription

- (a) The maximum number of Shares which may be allotted and issued upon the exercise of all outstanding options granted and yet to be exercised under the Scheme and any other share option scheme adopted by the Group must not in aggregate exceed 30% of the share capital of the Company in issue from time to time.
- (b) The total number of the Shares which may be allotted and issued upon the exercise of all options (excluding, for this purpose, options which have lapsed in accordance with the terms of the Scheme and any other share option scheme of the Group) to be granted under the Scheme and any other share option scheme of the Group must not in aggregate exceed 10% of the number of Shares in issue as at the date of approval of the Scheme ("General Scheme Limit").
- Subject to (a) above but without prejudice to (d) below, the (C) Company may seek approval of the Shareholders in general meeting to refresh the General Scheme Limit provided that the total number of Shares which may be allotted and issued upon exercise of all options to be granted under the Scheme and any other share option scheme of the Group must not exceed 10% of the number of Shares in issue as at the date of approval of the refreshed limit and, for the purpose of calculating the refreshed limit, options (including those outstanding, cancelled, lapsed or exercised in accordance with the Scheme and any other share option scheme of the Group) previously granted under the Scheme and any other share option scheme of the Group will not be counted. The grantee, his associates and all core connected persons of the Company must abstain from voting in favour at such general meeting, except that any connected person may vote against the relevant resolution at the general meeting provided that his intention to do so has been stated in the circular. Any vote taken at the meeting to approve the grant of such options must be taken on a poll. Any change in the terms of options granted to a substantial shareholder or an independent non-executive Director or any of their respective associates must be approved by the Shareholders in general meeting.

Unless otherwise determined by the Board and stated in the offer for the grant of options to a grantee, there is no minimum period required under the Scheme for the holding of an option before it can be exercised.

# 7. Amount payable on acceptance of the option and the period within which payment must be made:

A nominal consideration of HK\$1 is payable on acceptance of the grant of an option and options may be accepted by a participant within 21 days from the date of the offer of grant of the option.

### 8. Basis of determining the exercise price:

The exercise price for the Shares under the Scheme shall be a price determined by the Board, but shall not be less than the highest of (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of the offer for the grant, which must be a business day; (ii) the average closing price of Shares as stated in the Stock Exchange's daily quotations for the five business days immediately preceding the date of the offer for the grant; and (iii) the nominal value of a Share.

### 9. Remaining life of the Scheme:

The Scheme became effective on 20 May 2015 and unless otherwise cancelled or amended, will remain in force for a period of 10 years from that date.

#### **OPINION**

We have audited the consolidated financial statements of China New City Commercial Development Limited (the "Company") and its subsidiaries (the "Group") set out on pages 89 to 251, which comprise the consolidated statement of financial position as at 31 December 2021, and the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2021, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board (the "IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

#### **BASIS FOR OPINION**

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). We reviewed rental contracts, compared the prices of the investment properties with the unit prices of adjacent similar properties that were benchmarked in the valuation process, assessed assumptions relating to future market rents, compared the current prices in the active market for adjacent similar properties, and assessed the discount rates and future maintenance costs applied based on historical experiences with the involvement of our internal valuation specialists, who focused on the term yield, reversionary yield and market unit rent. We also assessed the adequacy of the disclosures in the consolidated financial statements.

The estimation of the net realisable value involved significant judgement.

## 1. CORPORATE AND GROUP INFORMATION

China New City Commercial Development Limited (the "Company") is a limited liability company incorporated as an exempted company in the Cayman Islands on 2 July 2013 under the Companies Law (revised) of the Cayman Islands. The registered office address of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The Company was separately listed on the Main Board of the Stock Exchange of Hong Kong Limited (the "SEHK") with the stock code "1321" on 10 July 2014 and raised capital amounting to HK\$608 million from the market.

The Company is an investment holding company. The Company and its subsidiaries (together, the "Group") were members of Zhong An Group Limited ("Zhong An") and its subsidiaries ("Zhong An Group"). Zhong An, the shares of which have been listed on the Main Board of the Stock Exchange of Hong Kong Limited ("Stock Exchange") since November 2007, is the holding company of Zhong An Group.

The Group is principally engaged in commercial property development, leasing and hotel operations.

In the opinion of the Company's directors (the "Directors"), the ultimate holding company of the Company is Whole Good Management Limited, a company incorporated in the British Virgin Islands on 3 May 2007.

#### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs"), which comprise standards and interpretations approved by the International Accounting Standards Board (the "IASB"), and International Accounting Standards and Standing Interpretations Committee interpretations approved by the International Accounting Standards Committee and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties, investment properties classified as held for sale, equity investments designated at fair value through other comprehensive income and financial assets at fair value through profit or loss which have been measured at fair value as explained in the accounting policies set out below. These financial statements are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

#### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31 December 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

#### 2.1 編製基準

- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

# 2.3 ISSUED BUT NOT YET EFFECTIVE INTERNATIONAL FINANCIAL REPORTING STANDARDS (CONTINUED)

The Group is in the process of making an assessment of the impact of these new and revised IFRSs upon initial application. So far, the Group considers that, these new and revised IFRSs are unlikely to have a significant impact on the Group's results of operations and financial position.

### 2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate and joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its joint ventures are eliminated to the extent of the Group's investments in the joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

When an investment in a joint venture is classified as held for sale, it is accounted for in accordance with IFRS 5 Non-current Assets Held for Sale and Discontinued Operations.

# **Business combinations and goodwill**

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

在初步確認後,商譽按成本減任何累計減值虧損計量。商譽至少每年進行減值測試一次或應任何事項的發生或環境的變化顯示賬面值可能發生減值時更頻繁地進行高值測試。本集團於12月31日進行商譽之在度減值測試。就減值測試而言,於業務自與時中所收購的商譽自收購日起分配至本等團各現金產出單元或單元組預期將從合併協同效益中獲益,而無視是否有其他本集團資產或負債被分配至該等單元或單元組。

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

#### Fair value measurement

The Group measures its investment properties and equity investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

#### 公允價值計量

本集團於各報告期末按公允價值計量其投資物業和股本投資。公允價值為於計量日期市場參與者在有序交易中出售資產可收取或轉讓負債須支付之價格。公允價值計量乃基於假設於資產或負債的主要市場,或倘無主要市場,則於資產或負債最有利的市場進行出售資產或轉讓負債的交易而釐定。主要或最有利市場須由本集團評估。一項資產或負債的公允價值於計量時乃採用市場參與者於對資產或負債定價時採用的假設,並假設市場參與者以其最佳經濟利益行事。

# Fair value measurement (continued)

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly

Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets, financial assets, completed properties held for sale, properties under development, investment properties and non-current assets/a disposal group classified as held for sale), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cashgenerating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cashgenerating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset, unless the asset is carried at a revalued amount, in which case the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

An assessment is made at the end of each reporting period as to whether there is any indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises, unless the asset is carried at a revalued amount, in which case the reversal of the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

# Property and equipment and depreciation

Property and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Cost may also include transfers from equity of any gains or losses on qualifying cash flow hedges of foreign currency purchases of property and equipment.

Expenditure incurred after items of property and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents a building under construction, which is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property and equipment when completed and ready for use.

# **Investment properties**

Investment properties are interests in land and buildings (including the leasehold property held as a right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Investment properties comprise completed investment properties and investment properties under construction. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss in the year of the retirement or disposal.

The Group determines whether completed properties held for sale and properties under development would be transferred to investment properties when, only when, there is a change in use, evidenced by the following criteria: (a) the Group has prepared a business plan that reflects the future rental income generated by the property and this is supported with evidence that there is demand for rental space; (b) the Group can demonstrate that it has the resources, including the necessary financing or capital, to hold and manage an investment property; (c) the change in use is legally permissible; (d) if the property must be further developed for the change in use, the development has commenced and (e) the change in use is approved by the board.

# Properties under development

Properties under development are stated at the lower of cost and net realisable value and comprise land costs, construction costs, borrowing costs, professional fees and other costs directly attributable to such properties incurred during the development period.

Properties under development which are already under construction or expected to be under construction within twelve months or have an explicit business plan for construction are classified as current assets. Other properties under development are classified as non-current assets.

# Completed properties held for sale

Completed properties held for sale are stated at the lower of cost and net realisable value. Cost is determined by an apportionment of the total costs of land and buildings attributable to the unsold properties. Net realisable value takes into account the selling price, less estimated costs to be incurred in selling the properties based on prevailing market conditions.

Other intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the other intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each reporting period.

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. It also applies the recognition exemption for leases of low-value assets to leases of office equipment and laptop computers that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under IFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to the statement of profit or loss.

Gains and losses on these financial assets are never recycled to the statement of profit or loss. Dividends are recognised as other income in the statement of profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably, except when the Group benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case such gains are recorded in other comprehensive income. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

### Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in the statement of profit or loss.

This category includes equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on equity investments classified as financial assets at fair value through profit or loss are also recognised as other income in the statement of profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

### 終止確認金融資產

金融資產(或(倘適用)一項金融資產之一部份或一組同類金融資產之一部份)在下列情況將首先終止確認(即自本集團綜合財務狀況表剔除):

當本集團已轉讓其收取該項資產所得現金流量的權利或已訂立一項轉付安排,會評估其有否保留該項資產所有權的絕大部份風險和回報,以及其程度。如本集團並無轉讓或保留該項資產的絕大部份風險及回報,且並無轉讓該項資產的控制權,本集團將按本集團的持續參與程度而繼續確認轉讓資產。在此情況下,本集團亦確認相關負債。已轉讓的資產及相關負債按反映本集團已保留的權利及責任的基準計量。

以轉讓資產擔保方式之持續參與按資產之 原賬面值與本集團可能被要求償還之代價 最高金額之較低者計量。

### Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### **General approach**

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

### 金融資產的減值

#### 一般方法

預期信貸虧損分兩個階段進行確認。就自初始確認以來未有顯著增加的信貸風險而言,本集團就未來12個月內可能發生違約事件而導致的信貸虧損(12個月預期信貸虧損)作出預期信貸虧損撥備。就自初始確認以來已顯著增加的信貸風險而言,不論何時發生違約,於餘下風險年期內的預期信貸虧損均須計提虧損撥備(全期預期信貸虧損)。

於各報告日期,本集團就金融工具之信貸 風險自初始確認以來有否大幅增加進行評 估。作出評估時,本集團將報告日期金融 工具發生違約之風險與初始確認日期金融 工具發生違約之風險進行比較,並會考慮 無需付出不必要的成本或努力即可獲得之 合理可靠資料,包括歷史經驗及前瞻性資 料。

#### General approach (continued)

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal

to 12-month ECLs

Stage 2 - Financial instruments for which credit risk

has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal

to lifetime ECLs

Stage 3 - Financial assets that are credit-impaired

at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at

an amount equal to lifetime ECLs

# Impairment of financial assets (continued)

#### Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

### **Financial liabilities**

#### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables, amounts due to related companies, lease liabilities and interest-bearing bank and other borrowings.

#### 簡化法

就並無重大融資成分或當本集團就此應用 不調整重大融資成分影響實際權宜方法的 應收貿易賬款而言,本集團於計算預期信 貸虧損時應用簡化法。根據簡化法,本集 團並無追溯信貸風險變動,而是根據各報 告日期的全期預期信貸虧損確認虧損撥 備。本集團已設立根據其過往信貸虧損經 驗計算之撥備矩陣,並按債務人之特定前 瞻性因素及經濟環境作出調整。

就包含重大融資成份及租賃應收款項之應 收貿易賬款而言,本集團於上述政策中選 擇於計算預期信貸虧損時採用簡化法作為 其會計政策。

### 金融負債

#### 初始確認與計量

金融負債於初始確認時被分類為貸款及借款或應付款項(如適用)。

初始確認所有金融負債時,按公允價值計量,若為貸款及借款以及應付款項,則須扣除直接歸屬之交易成本。

本集團的金融負債包括應付貿易賬款及其 他應付款項、應付關聯公司款項、租賃負 債以及計息銀行貸款及其他借款。

#### Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

#### Financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

#### Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in "Impairment of financial assets"; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

# 金融負債(續)

#### 其後計量

金融負債按其分類之其後計量如下:

#### 按攤銷成本計量之金融負債(貸款及借款)

在初始確認後,計息貸款及借款其後採用 實際利率法按攤銷成本計量,除非折現影 響不重大,這種情況下,它們按成本計量。 在終止確認負債以及透過實際利率進行攤 銷程序時,收益及虧損於損益表中確認。

攤銷成本按照考慮任何折現或收購溢價以 及作為實際利率一部份之費用或成本計算 所得。實際利率之攤銷包含於損益表的財 務費用中。

#### 財務擔保合約

本集團作出的財務擔保合約即要求發行人作出特定付款以償付持有人因特定債務人未能根據債務工具的條款償還到期款項而招致損失的合約。財務擔保合約初步按其公允價值確認為一項負債,並就作出該擔保直接產生的交易成本作出調整。於初始確認後,本集團按(i)根據「金融資產的減值」所載政策計量的預期信貸虧損撥備;及(ii)初始確認的金額減(如適用)所確認的累計收入金額(以較高者為準)計量財務擔保合約。

# **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

# Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and on disposal.

# Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

#### **Provisions**

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

A contingent liability recognised in a business combination is initially measured at its fair value. Subsequently, it is measured at the higher of (i) the amount that would be recognised in accordance with the general policy for provisions above; and (ii) the amount initially recognised less, when appropriate, the amount of income recognised in accordance with the policy for revenue recognition.

### 現金及現金等價物

就綜合現金流量表而言,現金及現金等價物包括手頭現金及活期存款,以及購入後通常於三個月內到期的可隨時轉換為已知金額現金的短期高變現能力但價值改變的風險不大的投資,減須於要求時償還的銀行透支,組成本集團現金管理的一部份。

就綜合財務狀況表而言,現金及現金等價物包括手頭現金及銀行存款(包括並無限制用途的定期存款及性質類似現金的資產)。

#### 撥備

倘因過往事件須承擔現時的責任(法定或推定),而承擔該責任可能導致日後資源外流,且對責任金額能夠可靠地估計,則確認撥備。

當折現的影響重大時,就撥備確認的金額 乃指預計在日後履行責任時所需開支在報 告期末的現值。由於時間流逝導致折現值 的金額的增加,乃作為財務費用在損益表 內入賬。

於業務合併中確認的或有負債初始確認時 以其公允價值計量。其後,其則以(i)根據上 述計提撥備的一般政策確認的金額;及(ii) 初始確認金額扣減(倘適用)按照收入確認 政策計算的收入金額中的較高者計量。

# **Employee retirement benefits**

Pursuant to the relevant regulations of the PRC government, the companies comprising the Group operating in Mainland China (the "PRC group companies") have participated in a local municipal government retirement benefit scheme (the "Scheme"), whereby the PRC group companies are required to contribute a certain percentage of the salaries of their employees to the Scheme to fund their retirement benefits. The only obligation of the Group with respect to the Scheme is to pay the ongoing contributions under the Scheme. Contributions under the Scheme are charged to the statement of profit of loss as incurred. Contributions paid to the Scheme for an employee are not available to reduce the Group's future obligations to the Scheme even if the employee leaves.

Employee benefits to all eligible employees of the overseas subsidiaries are made in accordance with the rules set forth in the collective labor agreement, and recorded as an expense in the period they are due as a charge to the statement of profit or loss.

#### Income tax

Income tax comprises current and deferred tax and land appreciation tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

### 僱員退休福利

按照中國政府的有關法規,在中國內地經營的公司(「中國集團公司」)已經參加了當地市政府的退休金計劃(「該計劃」),該計劃要求中國集團公司按公司員工基本工資一定比例向該計劃供款,為職工的退休福利提供資金。本集團在該計劃的唯一義務是持續向該計劃繳納所規定的供款。認計劃項下的供款在發生時計入損益表。即使僱員離職,為僱員向該計劃作出供款並不適用於減少本集團對該計劃的未來責任。

向海外附屬公司所有合資格僱員提供的僱 員福利乃根據集體勞動協議所載規則作 出,並於到期期間入賬為開支,自損益扣 除。

### 所得稅

所得稅包括即期及遞延稅項以及土地增值稅。與在損益以外確認的項目有關的所得稅在損益以外的其他全面收益內確認或直接於權益內確認。

當期稅項資產及負債以預期從稅務當局收回或向其支付之金額予以估量,基於本集團業務經營所在國家普遍通行之解釋與慣例,按照已頒佈或在報告期末前已經實質執行之稅率(及稅務法例)來確定。

遞延稅項乃於報告期末就資產及負債的稅 基與其作財務報告用途的賬面值之間的所 有暫時差額採用負債法作出撥備。

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- Deferred tax assets arise in the following transactions: the initial recognition of goodwill, or the initial recognition of assets or liabilities arising from a transaction that has the following characteristics: the transaction is not a business combination and, at the time the transaction occurs, affects neither accounting profit nor taxable income or deductible losses; and
- in respect of taxable temporary differences associated with investments in subsidiaries and joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries and joint ventures, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

# 所得稅(續)

遞延稅項負債根據全部應課稅暫時差額確 認入賬,但以下情況除外:

- 遞延所得稅資產是在以下交易中產生的:商譽的初始確認,或者具有以下特徵的交易中產生的資產或負債的初始確認:該交易不是企業合併,並且交易發生時既不影響會計利潤也不影響應納稅所得額或可抵扣虧損;及

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

# **Government grants**

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to the statement of profit or loss by way of a reduced depreciation charge.

### Revenue recognition

#### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

#### Revenue from contracts with customers (continued)

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

#### (a) Revenue from the sales of properties

For property development and sales contracts for which the control of the property is transferred at a point in time, revenue is recognised when the purchasers obtain the physical possession or the legal title of the completed properties and the Group has the present right to payment from the purchasers.

#### (b) Revenue from hotel operation

Revenue from hotel operation is derived from room rental, food and beverage sales and income from the provision of other ancillary services, and is recognised when the services are rendered.

(c) Revenue from property management and other services

Revenue from property management and other services is recognised over the scheduled period on a straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group.

#### Revenue from other sources

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

#### **Contract liabilities**

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

# Commission in obtaining contracts

Sales commissions incurred directly attributable to obtaining a contract, if recoverable, are capitalised and recorded in other assets. Capitalised sales commissions are charged to profit or loss when the revenue from the related property sale is recognised and are included as selling and marketing expenses at that time. The Group has elected to apply the practical expedient and did not recognise the effects of the sales commission if the time period is one year or less.

#### **Share-based payments**

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants after 7 November 2002 is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model, further details of which are given in note 32 to the financial statements.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

#### **Dividends**

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

Interim dividends are simultaneously proposed and declared. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

### Foreign currencies

The functional currency of the Company is the Hong Kong dollar ("HK\$"), and the functional currencies of subsidiaries incorporated outside Mainland China are the "HK\$", the United States dollar ("US\$") and the Great Britain Pound ("GBP"), respectively. The functional currency of Mainland China subsidiaries is the RMB. As the Group mainly operates in Mainland China, the RMB is used as the presentation currency of the Group. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss with the exception of monetary items that are designated as part of the hedge of the Group's net investment of a foreign operation. These are recognised in other comprehensive income until the net investment is disposed of, at which time the cumulative amount is reclassified to the statement of profit or loss. Tax charges and credits attributable to exchange differences on those monetary items are also recorded in other comprehensive income.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of non-PRC established subsidiaries are currencies other than the RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into RMB at the exchange rates that approximate to those prevailing at the dates of the transactions.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of non-PRC established subsidiaries are translated into RMB at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of non-PRC established companies which arise throughout the year are translated into RMB at the weighted average exchange rates for the year.

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

### **Judgements**

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

#### (i) Property lease classification – Group as a lessor

The Group has entered into commercial property leases on its investment property portfolio. The Group has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease term not constituting a major part of the economic life of the commercial property and the present value of the minimum lease payments not amounting to substantially all the fair value of the commercial property, that it retains substantially all the significant risks and rewards incidental to ownership of these properties which are leased out and accounts for the contracts as operating leases.

### (ii) Classification between investment properties, completed properties held for sale and owner-occupied properties

The Group determines whether a property qualifies as an investment property and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group.

Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately, the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

### (iii) Classification of current and non-current properties under development

The Group classifies properties under development according to the construction progress and estimated commencement date of pre-sale. Properties under development are classified as current assets after the construction commences or having a clear plan for construction. As for the rest properties under development, the Group classify them as non-current.

### **Estimation uncertainty**

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below:

#### (i) Fair value of investment properties

Investment properties were revalued based on the appraised market value by independent professional valuers. Such valuations were based on certain assumptions, which are subject to uncertainty and might materially differ from the actual results. In making the estimate, the Group considers information from current prices in an active market for similar properties and uses assumptions that are mainly based on market conditions existing at the end of the reporting period.

In the absence of current prices in an active market for similar properties, the Group considers information from a variety of sources, including:

- current prices in an active market for properties of a different nature, condition or location or subject to different lease or other contracts, adjusted to reflect those differences;
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the dates of the transactions that occurred at those prices; and

- (b) 活躍程度稍遜之市場所提供類 似物業近期價格(可予調整以 反映自按有關價格成交當日以 來經濟狀況之任何變動);及

#### (i) Fair value of investment properties (continued)

(c) discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing leases and other contracts and (when possible) by external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

The principal assumptions for the Group's estimation of the fair value include those related to current market rents for similar properties in the same location and condition, appropriate discount rates, expected future market rents and future maintenance costs. The carrying amount of investment properties at 31 December 2021 was RMB5,290,500,000 (2020: RMB5,414,600,000). Further details, including the key assumptions used for fair value measurement, are given in note 13 to the financial statements.

### (ii) Net realisable value of properties under development and completed properties held for sale

The Group's properties under development and completed properties held for sale are stated at the lower of cost and net realisable value. Based on the Group's historical experience and the nature of the subject properties, the Group makes estimates of the selling prices, the costs of completion of properties under development, and the costs to be incurred in selling the properties based on prevailing market conditions.

#### (i) 投資物業公允價值(續)

(c) 根據未來現金流量之可靠估計 而作出之折現現金流量預測, 該預測乃根據任何現有租賃及 其他合約之條款,以及(如有可 能)外在因素(如相同地點及狀 況之類似物業之現行市場租金 等)而作出,並採用可反映當時 市場對不確定之現金流量金額 及時間之評估之折現率計算。

本集團估計公允價值的主要假設包括地處相同位置及狀況的類似物業之當前市場租金、適用折現率、預計未來市場租金及未來維修成本。於2021年12月31日,投資物業賬面值為人民幣5,290,500,000元(2020年:人民幣5,414,600,000元)。進一步詳情(包括公允價值計量所使用的主要假設)載於財務報表附註13。

### (ii) 開發中物業及持作銷售已落成物業 的可變現淨值

本集團開發中物業及持作銷售已落 成物業按成本及可變現淨值兩者的 較低者列賬。本集團根據其過往經 驗及有關物業的性質,基於現行市 況估計售價、開發中物業竣工成本 及銷售物業產生的成本。

### (ii) Net realisable value of properties under development and completed properties held for sale (continued)

If there is an increase in costs to completion or a decrease in net sales value, the net realisable value will decrease and this may result in a provision for properties under development and completed properties held for sale. Such provision requires the use of judgements and estimates. Where the expectation is different from the original estimate, the carrying value and provision for properties in the period in which the estimate is changed will be adjusted accordingly.

#### (iii) PRC land appreciation tax ("LAT")

LAT in the PRC is levied at progressive rates ranging from 30% to 60% on the appreciation of land value, being the proceeds from sale of properties less deductible expenditures including land costs, borrowing costs and other property development expenditures.

The subsidiaries of the Group engaging in the property development business in Mainland China are subject to LAT. However, the implementation of these taxes varies amongst various cities in Mainland China and the Group has not finalised its LAT returns with various tax authorities. Accordingly, significant judgement is required in determining the amount of land appreciation and its related taxes. The ultimate tax determination is uncertain during the ordinary course of business. The Group recognises these liabilities based on management's best estimates. Where the final tax outcome of these matters is different from the amounts that were initially recorded, the differences will impact the statement of profit or loss and the provision for LAT in the period in which the determination is made.

### (ii) 開發中物業及持作銷售已落成物業 的可變現淨值(續)

倘若完工成本增加,或售價淨額減少,則可變現淨值將會減少,並可能因而導致就開發中物業及持作銷售已落成物業作出撥備。該撥備須運用判斷及估計。在預期與原有估計有差異時,將於該估計有改變的期間對物業的賬面值及撥備作出相應調整。

#### (iii) 中國土地增值稅(「土地增值稅」)

中國的土地增值稅按土地增值(即出售物業所得款項減可扣減支出(包括土地成本、借款成本及其他物業發展支出))以累進稅率30%至60%徵收。

本集團在中國內地從事物業開發業務的附屬公司須繳納土地增值稅稅。然而,在中國內地不同城市,該會有差異,且本集團增原不同稅務機關落實其土地增值銀不同稅務機關落實其土地增值金額及其相關稅項時須作出重大均項層之。本集團按照管理局線的資產定。本集團按照管理屬的事金數,則有關差異與最初記賬的益表的同,則有關差異將會影響損稅作出數衡。

#### (iv) Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 31 December 2021 was nil (2020: RMB98,995,000). Further details are given in note 16 to the financial statements.

#### (v) Leases – Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entityspecific estimates (such as the subsidiary's stand-alone credit rating).

#### (iv) 商譽減值

#### (v) 租賃-估計增量借款利率

本集團無法輕易釐定和賃內所隱含 的利率,因此,其使用增量借款利率 (「增量借款利率」) 計量租賃負債。 增量借款利率為本集團於類似經濟 環境中為取得與使用權資產價值相 近之資產而以類似抵押品於類似期 間借入所需資金應支付的利率。因 此,增量借款利率反映本集團「應支 付」的利率,當無可觀察的利率時(例 如就並無訂立融資交易的附屬公司 而言) 或當須對利率進行調整以反映 租賃的條款及條件時(例如當租賃並 非以附屬公司的功能貨幣訂立時), 則須作出估計。當可觀察輸入數據 可用時,本集團使用可觀察輸入數 據(例如市場利率)估計增量借款利 率,並須作出若干實體特定的估計 (例如附屬公司的獨立信貸評級)。

### (vi) Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-ofuse assets) at the end of each reporting period. Other nonfinancial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

#### (vii) Fair value of unlisted equity investments

The unlisted equity investments have been valued based on a market-based valuation technique as detailed in note 40 to the financial statements. The valuation requires the Group to determine the comparable public companies (peers) and select the price multiple. In addition, the Group makes estimates about the discount for illiquidity and size differences. The Group classifies the fair value of these investments as Level 3. The fair value of the unlisted equity investments at 31 December 2021 was RMB335,050,000 (2020: RMB392,590,000). Further details are included in note 18 to the financial statements.

#### (vi) 非金融資產(商譽除外)減值

本集團於各報告期末評估所有非金 融資產(包括使用權資產)是否存在 任何減值跡象。當存在賬面值不可 收回的跡象時,會就其他非金融資 產進行減值測試。當資產或現金產 出單元的賬面值超出其可收回金額 (即其公允價值減出售成本及其使 用價值的較高者),則存在減值。公 允價值減出售成本乃根據白類似資 產的公平交易中的具約束力銷售交 易可取得的數據或可觀察的市場價 格減出售該資產的增量成本計算。 當進行使用價值計算時,管理層必 須估計來自該資產或現金產出單元 的預期未來現金流量,並選擇合適 貼現率以計算該等現金流量的現值。

#### (vii) 非上市股本投資的公允價值

非上市股本投資乃根據市場基準估值技術估值,詳情載於財務報表附註40。該估值要求本集團釐定可資比較公眾公司(同業)並選擇價格倍數。此外,本集團作讓有關非流動性及規模差異的折價值計。本集團將該等投資的公允價值分類為第三級。於2021年12月31日,非上市股本投資的公允價值為人民幣335,050,000元(2020年:人民幣392,590,000元)。進一步詳情載於財務報表附註18。

### (viii) Provision for ECLs on trade receivables and other financial assets

The Group uses a provision matrix to calculate ECLs for trade receivables and other financial assets. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e. by service type, customer type and rating).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions are expected to deteriorate over the next year which can lead to an increased number of defaults in the property development sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future.

### (viii) 應收貿易賬款及其他金融資產預期 信貸虧損撥備

本集團使用撥備矩陣計算應收貿易 賬款及其他金融資產的預期信貸虧 損。撥備率乃基於多個具有類似虧 損模式(即服務類型、客戶類型及評 級)之客戶分部組合的逾期天數釐 定。

撥備矩陣初始基於本集團的過往觀察所得違約率。本集團將調整矩陣,以根據前瞻性資料調整過往信貸虧損經驗。例如,若預測經濟狀況預期在來年惡化,可能導致物業開發部門違約事件增加,則過往違約率予以調整。於各報告日期,過往觀察所得違約率予以更新,並對前瞻性估計改動進行分析。

對過往觀察所得違約率、經濟狀況 預測及預期信貸虧損之間相關性的 評估為一項重要估計。預期信貸虧 損的金額受情況變化及預測經濟狀 況影響。本集團的過往信貸虧損經 驗及經濟狀況預測亦可能無法代表 客戶未來的實際違約。

### 4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on income derived from business and has four reportable operating segments as follows:

- (a) the commercial property development segment develops and sells commercial properties in Mainland China and Japan;
- the property rental segment leases investment properties in Mainland China;
- (c) the hotel operations segment owns and operates hotels; and
- (d) the "others" segment comprises, the Group's property management services business, the Group's project management business and other business that the Group is involved in. On 3 February 2021, the Group had entered into an equity transfer agreement with Zhong An Group to dispose the entire equity interest in Zhejiang Runzhou Property Services Co., Ltd., Yuyao Zhongli Property Management Co., Ltd. and Hangzhou Zhonghong Property Service Co., Ltd., all of which are engaged in commercial property management business at an aggregate of consideration of RMB104.65 million (equivalent to approximately HK\$125.58 million) ("Transfers"). The Transfers was fully completed on 13 April 2021. Ever since the completion of the Transfers, the Group is no longer engaged in commercial property management business.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/loss, which is a measure of adjusted profit/loss before tax from continuing operations. The adjusted profit/loss before tax from continuing operations is measured consistently with the Group's profit/loss before tax from continuing operations except that interest income and finance costs are excluded from the measurement.

Segment assets exclude deferred tax assets, tax recoverable, pledged deposits, cash and cash equivalents, and other unallocated head office and corporate assets as these assets are managed on a group basis.

Segment liabilities exclude interest-bearing bank and other borrowings, tax payable, deferred tax liabilities and other unallocated head office and corporate liabilities as these liabilities are managed on a group basis.

- (d) 「其他」分部包括本集團的物業管理服務業務、本集團的項目管理業務及本集團涉及的其他業務。於2021年2月3日,本集團與眾安集團就按總代價人民幣104.65百萬元(相當於約125.58百萬港元)出售浙江潤洲物業服務有限公司、餘姚眾力物業服務有限公司及杭州眾宏物業服務有限公司的全部股權訂立股權轉讓協議,該等公司均從事商業物業管理業務(「轉讓」)。轉讓已於2021年4月13日悉數完成。自完成轉讓起,本集團不再從事商業物業管理業務。

管理層會單獨監察本集團各經營分部業績 以作出有關資源分配及表現評估的決定。 分部表現根據可報告分部利潤/虧損(以 來自持續經營業務之經調整除稅前利潤/ 虧損計量)予以評估。來自持續經營業務之 經調整除稅前利潤/虧損與本集團來自持 續經營業務之除稅前利潤一貫計量,惟利 息收入及融資成本均不計入該計量內。

分部資產不包括遞延稅項資產、可收回稅 項、質押存款、現金及現金等價物及其他 未分配總辦事處及企業資產,原因是該等 資產在集團層面統一管理。

分部負債不包括計息銀行及其他借款、應繳稅項、遞延稅項負債及其他未分配總辦事處及企業負債,原因是該等負債在集團層面統一管理。

### 10. INCOME TAX

The Group's subsidiaries incorporated in Hong Kong and United Kingdom were not liable for income tax as they did not have any assessable profits currently arising in Hong Kong and United Kingdom during the year (2020: Nil).

The provision for the PRC income tax has been provided at the applicable income tax rate of 25% (2020: 25%) on the assessable profits of the Group's subsidiaries in Mainland China.

LAT is levied at progressive rates ranging from 30% to 60% on the appreciation of land value, being the proceeds from the sale of properties less deductible expenditures including land costs, borrowing costs and other property development expenditures. The Group has estimated, made and included in taxation a provision for LAT according to the requirements set forth in the relevant PRC tax laws and regulations. Prior to the actual cash settlement of the LAT liabilities, the LAT liabilities are subject to the final review/approval by the tax authorities.

At 31 December 2021, certain items of the Group's property and equipment with a net carrying amount of approximately RMB1,142,363,000 (2020: RMB1,236,965,000) were pledged to secure interest-bearing bank and other borrowings granted to the Group as disclosed in note 30.

During the year ended 31 December 2021, impairments of RMB11,436,000 was provided in respect of the leasehold improvements and office equipment with carrying value in aggregate amounted to RMB10,670,000 and RMB766,000, respectively. The impairment was provided for these assets when there are indicators of impairment such as the pre-education center close down schedule implemented by the Group, leasehold improvements unremovable and obsolete office equipment had been fully impaired. By taking into account the fact that these assets would not be economically viable for their remaining life and there was no identified alternative utilisation, the directors of the Group assessed the recoverable amount of these assets were nil and made full provision on their carrying value.

The fair value represents the amount at which the assets could be exchanged between a knowledgeable and willing buyer and a seller in an arm's length transaction at the date of valuation, in accordance with International Valuation Standards.

Under the discounted cash flow method, fair value is estimated using assumptions regarding the benefits and liabilities of ownership over the asset's life including an exit or terminal value. This method involves the projection of a series of cash flows on a property interest. A market-derived discount rate is applied to the projected cash flow in order to establish the present value of the income stream associated with the asset. The exit yield is normally separately determined and differs from the discount rate.

The duration of the cash flows and the specific timing of inflows and outflows are determined by events such as rent reviews, lease renewal and related reletting, redevelopment or refurbishment. The appropriate duration is driven by market behaviour that is a characteristic of the class of property. The periodic cash flow is estimated as gross income less vacancy, non-recoverable expenses, collection losses, lease incentives, maintenance costs, agent and commission costs and other operating and management expenses. The series of periodic net operating income, along with an estimate of the terminal value anticipated at the end of the projection period, is then discounted.

Goodwill acquired through business combinations is allocated to the pre-education business cash-generating unit for impairment testing.

The recoverable amount of the pre-education business cashgenerating unit has been determined based on a value in use calculation using cash flow projections based on financial budgets covering a five-year period approved by senior management. The discount rate applied to the cash flow projections was 19.76% (2020: 21.52%) and cash flows beyond the five-year period were extrapolated using a growth rate of 2.24% (2020: 2.85%), which was the same as the long term average growth rate of the preeducation industry.

Assumptions were used in the value in use calculation of the pre-education business cash-generating unit for 31 December 2021. The following describes each key assumption on which management has based its cash flow projections to undertake impairment testing of goodwill:

Budgeted gross margins – The basis used to determine the value assigned to the budgeted gross margins is the average gross margins achieved in the year immediately before the budget year, increased for expected efficiency improvements, and expected market development.

Discount rate – The discount rate used is before tax and reflects specific risks relating to the relevant unit.

The values assigned to the key assumptions on the market development of the pre-education business and the discount rate are consistent with external information sources.

During the year, Covid-19 has negatively continued to affect the pre-education business operation, leading to decrease in pre-education business development and triggering the impairment provision. The directors have consequently determined impairment of goodwill based on the valuation report issued by an independent professional valuer.

The Group seeks to maintain strict control over its outstanding receivables to minimise credit risk. Overdue balances are reviewed regularly by senior management. In view of the aforementioned and the fact that the Group's trade receivables related to various diversified customers, there is no significant concentration of credit risk. The Group does not hold any collateral or other credit enhancements over its trade receivable balances. The balances of trade receivables are non-interest-bearing and unsecured.

As at 31 December 2021, these guarantee deposits amounted to approximately RMB268,856,000 (2020: RMB74,204,000).

Besides, certain of the Group's bank accounts of approximately RMB64,109,000 (2020: RMB40,572,000) were pledged to banks for the timely repayment of the loans as disclosed in note 30.

#### 32. OTHER RESERVE

Other reserve represented the reserve from the share option scheme adopted by Zhong An Group Limited (the "Parent Company") and China New City Commercial Development Limited (the "Company").

The parent company of the Group, which operates a share option scheme (the "Scheme") for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the operations. The Scheme became effective on 15 May 2009 and as at 31 December 2021, there were no options granted under to Scheme.

The Company adopted an equity-settled share option scheme in 2015 (the "New Scheme") for the purpose of providing incentives and rewards to eligible persons, including the Company's directors, independent non-executive directors, employees of the Group and other eligible participants, who contribute to the success of the Group's operations. The New Scheme became effective on 20 May 2015 and, unless otherwise cancelled or amended, will remain in force for 10 years from the offer date.

The maximum number of shares issuable under share options to each eligible person in the New Scheme within any 12-month period is limited to 1% of the shares of the Company in issue at any time. Any further grant of share options in excess of this limit is subject to shareholders' approval in a general meeting.

In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the closing price of the Company's shares at the date of grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

The offer of a grant of share options may be accepted within 21 days from the date of offer, upon payment of a nominal consideration of HK\$0.998 by each grantee with no other consideration being payable by the grantee. An option may be exercised in accordance with the terms of the New Scheme at any time during a period commencing on such date on or after the date on which the option is granted as the Board may determine in granting the option and expiring at the close of business on such date as the Board may determine in granting the option but in any event shall not exceed 10 years from the date of grant.

The exercise price of share options is determined by the directors, but may not be less than the higher of (i) the Stock Exchange closing price of the Company's shares on the date of offer of the share options; and (ii) the average Stock Exchange closing price of the Company's shares for the five trading days immediately preceding the date of offer, provided that the exercise price shall not be less than the nominal value of the ordinary shares of the Company, and (iii) per value of the share.

#### (b) Claim arising from the litigation

As disclosed in note 19, on 7 January 2019, the Company allotted and issued 178,280,000 shares to Hangzhou Oriental Culture Tourism Group Co., Ltd. ("the Seller") for the purpose of acquiring 22.65% of equity interests in Zhejiang Xinnongdu Industrial Co., Ltd. ("XND") under the equity transfer agreement announced on 20 July 2018 ("the Transaction"). However, the Seller had filed a lawsuit against the Company to cancel the Transaction. The Company had lost the lawsuit in the first trial verdict, and had appealed to higher court. Currently, the lawsuit is still in process. The directors, based on the advice from the Group's legal counsel, believe that they have a valid defence against the allegation in their appeal to higher court, and have not provided for the claim arising from the litigation, other than the related legal and other costs.

### 41. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise cash and cash equivalents, short term deposits, lease liabilities and interest-bearing bank and other borrowings. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as trade receivables and trade payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The Group does not hold or issue derivative financial instruments for trading purposes. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below:

### (a) Interest rate risk

The Group has no significant interest-bearing assets. The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's bank and other borrowings with floating interest rates. The Group has not used any interest rate swaps to hedge its interest rate risk.

The following table demonstrates the sensitivity to a reasonably possible change in interest rates, with all other variables held constant, of the Group's profit before tax (through the impact on floating rate borrowings) and the Group's equity, assuming all the increases or decreases are dealt with in profit or loss, without consideration of interest capitalisation.

### (e) Capital management

To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares. The Group is not subject to any externally imposed capital requirements. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2021 and 2020.
