VOLUNTARY ANNOUNCEMENT

**Power Generation and Electricity Sold
for the First Quarter of 2013**

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the consolidated gross power generation of the Company and its subsidiaries (collectively, the “Group”) for the first quarter ended 31 March 2013 amounted to 13,364,401MWh, representing a year-on-year increase of 3.68% while its consolidated total electricity sold amounted to 12,697,185MWh, representing a year-on-year increase of 4.34%. Power generation increased was mainly due to the surge in the Group’s hydropower generation for more than 70% during the period.

The respective gross power generation and total net generation of the main generating units of the Group for the first quarter ended 31 March 2013 are as follows:
