Power Generation and Electricity Sold for the First Three Quarters of 2013

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, for the nine months ended 30 September 2013, the combined total power generation of the Company and its subsidiaries (collectively, the “Group”) amounted to 42,210,060MWh, representing an increase of 5.85% over the same period last year while its combined total electricity sold amounted to 40,122,775MWh, representing an increase of 6.09% over the same period last year. During the third quarter of 2013, the Group recorded significant increase in coal-fired power generation due to reduction in hydropower generation and greater demand for electricity driven by high temperatures.

The increase in cumulative power generation for the first three quarters of 2013 was mainly due to the increase in the electricity consumption in China and the additional contribution from the Group’s new power generating units which commenced commercial operation during the period.

The respective total power generation and total electricity sold of the Group’s main generating units for the nine months ended 30 September 2013 were as follows:
