Power Generation and Electricity Sold for the First Half of 2015

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, for the six months ended 30 June 2015, the combined total power generation of the Company and its subsidiaries (collectively, the “Group”) amounted to 29,419,054MWh, representing a decrease of 10.11% over the same period last year while its combined total electricity sold amounted to 28,219,065MWh, representing a decrease of 9.88% over the same period last year.

During the first half of 2015, certain regions where the Group’s coal-fired power generating units are located, the surge in hydropower generation squeezed the space for coal-fired power generation and reduced the utilization hours for coal-fired power generating facilities.

The respective total power generation and total electricity sold of the Group’s main generating units for the six months ended 30 June 2015 are as follows:

Notes:

- (1) The first 1,000MW new coal-fired power generating unit of Pingwei III commenced commercial operation in May 2015.
- (2) For Wan Mi Po hydropower plant, its electricity sold for the first half of 2015 was higher than that of its power generation because of some electricity sales rewarded by the grid corporation during the period.

- (3) The twenty-five new wind power generating units of Yaoposhan of total installed capacity of 50MW commenced commercial operation during November to December 2014 and February 2015 respectively.
- (4) The thirty-three new wind power generating units of Shanshan of total installed capacity of 49.5MW commenced commercial operation during March 2015.
