Electricity Sold for February 2024

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “Group”) in February 2024 amounted to 9,076,224MWh, representing an increase of 30.42% compared with the same period last year, while the total electricity sold for the first two months of 2024 was 19,424,425MWh, representing an increase of 35.92% compared with the same period last year.

The Group’s total electricity sold for the two months ended 29 February 2024 presented by type of power plants is as follows:
