Electricity Sold for July 2024

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “Group”) in July 2024 amounted to 12,243,061MWh, representing an increase of 29.22% compared with the same period last year, while the combined total electricity sold for the first seven months of 2024 was 76,587,215MWh, representing an increase of 32.65% compared with the same period last year.

The Group’s total electricity sold in July 2024 and for the seven months ended 31 July 2024 presented by type of power plants are as follows:
