Electricity Sold for August 2024

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “Group”) in August 2024 amounted to 11,186,433MWh, representing an increase of 22.30% compared with the same period last year, while the combined total electricity sold for the first eight months of 2024 was 87,773,648MWh, representing an increase of 31.24% compared with the same period last year.

The Group’s total electricity sold in August 2024 and for the eight months ended 31 August 2024 presented by type of power plants are as follows:
