Electricity Sold for February 2025

China Power International Development Limited (the “**Company**”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “**Group**”) in February 2025 amounted to 9,804,644MWh, representing an increase of 8.03% compared with the same period last year, while the combined total electricity sold for the first two months of 2025 was 19,785,981MWh, representing an increase of 1.86% compared with the same period last year.

The Group’s total electricity sold in February 2025 and for the two months ended 28 February 2025 presented by type of power plants are as follows:
