### Electricity Sold for April 2025

China Power International Development Limited (the “**Company**”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “**Group**”) in April 2025 amounted to 10,203,229MWh, representing a decrease of 5.94% compared with the same period last year, while the combined total electricity sold for the first four months of 2025 was 40,950,892MWh, representing an increase of 0.33% compared with the same period last year.

The Group’s total electricity sold in April 2025 and for the four months ended 30 April 2025 presented by type of power plants are as follows:
